9 For an ordinance approving and providing for the execution of a proposed grant  
10 agreement between the City and County of Denver and the United States of  
11 America, Federal Emergency Management Agency, concerning the "Incident  
12 Management Team Pilot FY10 " program and the funding therefor.

14 WHEREAS, the City and County of Denver has given due consideration to said proposed  
15 Grant Agreement;

16 NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY  
17 OF DENVER:

18 Section 1. The proposed Grant Agreement, under CFDA No. 97.007, between the United  
19 States of America, Federal Emergency Management Agency, and the City and County of  
20 Denver, which is identified as Grant Number EMD-2010-GR-1006, a copy of which is duly filed  
21 with the City Clerk, Filing No. 10-816, be and hereby is approved in all respects.

22 Section 2. The Mayor or his lawful successor and other proper officials of the City and  
23 County of Denver, in its behalf, are hereby authorized and directed to execute said Grant  
24 Agreement and the Clerk and Recorder of the City and County of Denver is hereby authorized  
25 and directed to attest and impress the official seal of the City and County of Denver on the Grant  
26 Agreement.

27 Section 3. The Mayor, his successor in office, or his duly authorized representatives, and  
28 other officials of the City are hereby authorized and directed to do all things required to be done  
29 in order to obtain payments under the Grant Agreement, including, but not limited to, filing  
30 requests for payments, contracting with persons and organizations in order to carry out the  
31 provisions of the Grant Agreement, filing reports and keeping records relating to fiscal and  
32 evaluation matters, and forwarding other materials to the Federal Emergency Management  
33 Agency.

34 Section 4. The payments made by the Federal Emergency Management Agency to the City  
35 pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and  
36 credited to Special Fund No. 12000, which is set forth and described in Section 20-18 of the  
37 Revised Municipal Code of the City and County of Denver.

1 Section 5. That it be and is hereby found and determined that the budget summary of said  
2 "Incident Management Team Pilot FY10" Program, Accounting Number 12100-0160101-M1086,  
3 is as follows, to be expended by the Director of Emergency Management and Homeland  
4 Security.

5 Federal Emergency Management Agency \$500,000

6 Authorization for expenditure of said funds following execution of said grant will cover the  
7 period from June 15, 2010 to September 30, 2011.

8 Section 6. The Manager of Finance of the City and County of Denver is hereby authorized  
9 and directed to make such book and record entries and to do such other things as may be  
10 necessary to accomplish the purposes of this Ordinance.
