**A BILL**

6 **For an ordinance making rescissions from the General Fund and making**  
7 **appropriations in the General Fund to make a cash transfer to the Affordable**  
8 **Housing Special Revenue Fund.**

10 **WHEREAS**, the City desires to reallocate current year savings from the General Fund to the  
11 Affordable Housing Special Revenue Fund; and

12 **WHEREAS**, said funds support City Council Amendment 1645, Series of 2023, to the  
13 Mayor’s Proposed 2024 Budget, to add \$5 million to the Affordable Housing Fund in 2023 for rental  
14 assistance (to be used in 2024) through Denver’s Temporary Rent and Utility Assistance (TRUA)  
15 program;

17 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**
