5 **A BILL**

6 **For an ordinance approving the Department of Transportation and Infrastructure**
7 **(DOTI) 2020 annual programs and waiving further City Council approval of**
8 **specific contracts implementing the annual programs.**

9 **WHEREAS**, under Charter § 3.2.6, the City Council has the authority to approve contracts of
10 \$500,000 or more; and

11 **WHEREAS**, under Charter § 3.2.6(H), the City Council has the authority to waive the
12 requirement that such contracts be submitted to the council for approval or disapproval under Charter
13 § 3.2.6, and

14 **WHEREAS**, City Council has reviewed the 2020 annual programs for the Department of

26 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

27 **Section 1.** Pursuant to Charter § 3.2.6(H), the City Council hereby approves the letting of

28 contracts to implement the 2020 annual programs of the Department of Transportation and

29 Infrastructure, as set forth above, and waives the requirement that contracts, as defined in Charter

30 § 3.2.6(A), let to implement the annual programs be submitted to City Council for approval or

31 disapproval under Charter § 3.2.6.

32 **Section 2. Quarterly Reports.** The Department of Transportation and Infrastructure shall

33 provide quarterly written reports to City Council listing all contracts let under its annual program,

34 including the name of the contractor, the amount of the contract, the term of the contract, the M/WBE

35 goals established for each contract and which contracts are included in the SBE set aside program.

36 The Department of Transportation and Infrastructure shall meet with City Council members upon

37 request.
