This ordinance request is to amend Chapter 22 of the Revised Municipal Code to establish the 2016, 2017 and 2018 salary of the Fire Chief, Deputy Chief, and Division Chiefs.

The proposed increase is mirrors the collective bargaining agreement (CBA) with the Denver Fire Fighters – Local 858. The agreement includes reopening 2013-2015 CBA to increase 2015 salary by 1.5% on July 1, 2015; 2% increase on January 1, 2016; 2% increase on July 1, 2016; 2% increase on January 1, 2017; 2% increase on July 1, 2017; and a 3% increase on January 1, 2018.
