5 **A BILL**

6 **For an ordinance making rescissions, cash transfers, and supplemental**  
7 **appropriations from the General Fund Contingency to Departments.**  
8

9 **WHEREAS**, the Real Estate Division of the Department of Finance requests budget to  
10 support the purchase of a building at 710 West Colfax Avenue to accommodate the City's  
11 personnel and services expansions; and

12 **WHEREAS**, the Denver Sheriff Department requires a budget adjustment to accommodate  
13 uniform employees' raises approved in the 2018-2019 Collective Bargaining Agreement, which  
14 was finalized after the 2018 budget was completed; and

15 **WHEREAS**, the North Denver Cornerstone Collaborative requests funding to support  
16 Navigate North, a tool to communicate traffic management impacts of construction in North  
17 Denver; and

18 **WHEREAS**, the Office of the Municipal Public Defender requires a budget adjustment to  
19 support contract attorneys to cover a new full-time General Sessions courtroom that was created in  
20 2018 after the 2018 budget was completed; and

21 **WHEREAS**, the Technology Services' Denver Marketing and Media Services division  
22 requires a budget adjustment to support 2018 operating expenses for Open Media Foundation that  
23 do not qualify for public, educational, and governmental access (PEG) funding;

25 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**  
26 **DENVER:**

28 **Section 1.** From appropriations heretofore made from the General Fund listed or indicated in  
29 the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation  
30 under the heading "Amount Rescinded" and transferred to the General Fund:
