FIRST AMENDMENT TO AIRPORT USE AND LEASE AGREEMENT

THIS FIRST AMENDMENT TO AIRPORT USE AND LEASE AGREEMENT ("First Amendment") is made and entered into as of the date state on the City's signature page below, by and between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado, on behalf of its Department of Aviation (the "City"), and AMERICAN AIRLINES, INC., a corporation organized and existing under and by virtue of the laws of the State of Delaware, and authorized to do business in the State of Colorado ("Airline") (each a "Party" and collectively, the "Parties").

WITNESSETH

WHEREAS, the City owns and operates Denver International Airport ("DEN" or the "Airport"); and

WHEREAS, Airline is engaged in the business of transporting persons, property, cargo and mail, or one or more thereof, by aircraft; and

WHEREAS, the Parties entered into that certain Airport Use and Lease Agreement, City Contract No. 202370503, executed on January 18, 2024 (the "Existing Agreement"); and

WHEREAS, by letter dated November 5, 2024, the City exercised its option to extend the term of the Existing Agreement for the first of two additional one-year periods pursuant to Section 9.01 of the Existing Agreement for a new expiration date of such term of December 31, 2025, and so that the City retains its option to extend such term for one additional one-year period; and

WHEREAS, the Parties wish to amend the Existing Agreement to modify the Demised Premises leased to Airline and update other provisions; and

NOW, THEREFORE, for and in consideration of the premises and other good and valuable consideration, the Parties agree as follows:

- 1. "Exhibit D" attached to the Existing Agreement is hereby deleted in its entirety and replaced with the new "Exhibit D" attached hereto.
- 2. Section 12.09, subsection B, of the Existing Agreement is hereby deleted in its entirety and replaced with the following:
 - "B. All notices required to be given to the Airline hereunder shall be in writing and shall be sent by certified mail, return receipt requested, addressed to:

American Airlines, Inc. Attn: Andrew Higgins 1 Skyview Drive MD 8E100 Fort Worth, TX 76155"

- 3. Except as modified by this First Amendment, all of the terms and conditions of the Existing Agreement shall remain in full force and effect.
- 4. This First Amendment shall not be effective or binding on the City until approved and fully executed by all signatories of the City and County of Denver.
