A BILL

For an ordinance transferring the administration of the “Emergency Food and Shelter Grant” program from the Department of Human Services to the Department of Housing Stability.

WHEREAS, the Department of Housing Stability (HOST) was created in 2019 to manage the City’s programs and services that are dedicated to individuals experiencing homelessness; and

WHEREAS, the Emergency Food and Shelter Grant is currently administered by the Department of Human Services under Fund No. 13001, the Federal Grants Fund, in the Human Services Special Revenue Fund Series; and

WHEREAS, transferring the grant to the Federal Grants Fund in the Community Development Special Revenue Fund Series, Fund No. 16001, will allow for HOST to assume administration of the grant program;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. Monies received from the “Emergency Food and Shelter” Grant shall be deposited into the Treasury of the City and credited to Special Revenue Fund No. 16000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver. The financial and programmatic administration of the Emergency Food and Shelter Grant shall transfer from Denver Human Services to the Department of Housing Stability, specifically to the Federal Grants Fund, Fund No. 16001, under the expending authority of the Executive Director of the Department of Housing Stability.


Section 2. The Chief Financial Officer of the City and County of Denver is hereby authorized and directed to make such book and record entries and to do such other things, such as making

1 adjustments to cash balances, as may be necessary to accomplish the purposes of this
