Three actions will be required for the RiNo GID’s \$3m financing of Brighton Blvd streetscape enhancements as follows:

1. **RiNo Denver GID Debt Authorization and IGA Approval** – These two items need to be approved by the District with City Council sitting in its capacity as the ex-officio Board of Directors of the GID.

- a. A resolution to approve entering into an IGA with the City dealing with the Brighton Boulevard streetscape enhancements.
