I. <u>DEPARTMENTAL MATTERS IN THE REGULAR COURSE OF BUSINESS:</u>

A. Boards and Commissions - Anthony Aragon

RR11-0770 Approves the Mayoral appointment of Lance Benninghoff to the Denver Women's Commission for a term effective immediately and expiring on June 30, 2013 or until a successor is duly appointed.

RR11-0771 Approves the Mayoral appointments of Benita Muñiz and Nadia Ahmad to the Human Rights & Community Relations Advisory Council for terms effective immediately and expiring on April 1, 2013 or until a successor is duly appointed

B. Budget and Management -

BR11-0775 Establishes a capital grant fund and appropriate budget to accompany the IGA between the City and County of Denver and the State of Colorado, Department of Transportation (CDOT) for the construction of a bicycle and pedestrian crossing at the Union Pacific Railroad Tracks at 47th Avenue and York Street, as approved by City Council in June 2010.

C. City Council -

BR11-0645 Concerning eligibility for medical marijuana business licensing for certain businesses where changes in ownership or location occur between July 1, 2010 and July 1, 2012.

D. Community Planning and Development -

BR11-0748 Changes the zoning classification from I-A (Industrial A) and UO-2 (Use Overlay 2 allows billboards) to C-MX-20 (Urban Center-Mixed Use-20 stories) on property at 2555 31st Street in Council District 9.

E. Denver International Airport -

BR11-0777 Adds \$250,000 to and extends by one year the contract with Parsons Brinckerhoff (for a total of \$650,000) to assist DIA in capital project planning.

F. Public Works -

- BR11-0727 Approves transfer of \$2,135,105 from Wastewater Management's Storm Capital Improvement fund to General Fund CIP account, specifically the Justice Center Grant fund, following transfer of assets to Wastewater Management for storm drainage purposes, namely a constructed wetland pilot project to demonstrate the benefit of a regional approach to storm water quality requirements under the City's MS4 permit.
- BR11-0776 Approves a \$588,253.50 contract with Colorado Boring Company for traffic signal system improvements at 52 intersections.
- BR11-0773 Vacates the entire alley bounded by Walnut, Larimer and 24th streets and Park Avenue West for the Arapahoe Square development project in Council District 9.
