4 **A RESOLUTION**

5 **Laying out, opening and establishing as part of the City street system a parcel**
6 **of land as a public alley, bounded by South Cherokee Street, West Iliff Avenue,**
7 **South Delaware Street, and West Wesley Avenue.**

12 described, and, subject to approval by resolution has laid out, opened and established the same as
13 a public alley;
