5 **A RESOLUTION**

6 **Laying out, opening and establishing as part of the City street system a parcel**  
7 **of land as Oak Street at its intersection with West 26<sup>th</sup> Avenue.**

10 determined that the public use, convenience and necessity require the laying out, opening and  
11 establishing as public streets designated as part of the system of thoroughfares of the municipality  
12 those portions of real property hereinafter more particularly described, and, subject to approval by  
13 resolution has laid out, opened and established the same as a public street;

14 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**

17 **Section 1.** That the action of the Manager of Public Works in laying out, opening and  
18 establishing as part of the system of thoroughfares of the municipality the following described  
19 portion of real property situate, lying and being in the City and County of Denver, State of  
20 Colorado, to wit:

21 **PARCEL DESCRIPTION ROW NO. 2015-0097-01-001**

22 A parcel of land located in the Northwest 1/4 of Section 31, Township 3 South,  
23 Range 68 West of the Sixth Principal Meridian, City and County of Denver, State of  
24 Colorado.

25 A parcel of land conveyed by Quit Claim Deed to the City & County of Denver,  
26 recorded on the 21st of May 1941 in Book 5490 Page 422 at the City and County of  
27 Denver Clerk & Records Office being more particularly described as follows:

28 The east fifteen (15) feet of Lots 31 to 48, both inclusive, Block 1, Sloan Lake Park  
29 Addition.

31 be and the same is hereby approved and said real property is hereby laid out and established and  
32 declared laid out, opened and established as Oak Street.

33 **Section 2.** That the real property described in Section 1 hereof shall henceforth be known  
34 as Oak Street.
