**A BILL**

**For an ordinance establishing a new fund in the Human Services Special Revenue Fund Series for the “Border Crisis Response Special Revenue Fund”.**

**WHEREAS**, Denver has experienced a significant influx of migrants and asylum seekers arriving from the southern boarder since December 2022; and

**WHEREAS**, the City activated the Emergency Operations Center, and agencies and departments within the City and County of Denver have been providing services, including shelter, food, and other needed services on an emergency basis; and

**WHEREAS**, the City desires to coordinate services and funding in a centralized manner; and

**WHEREAS**, companion ordinance CB23-0829 is also being submitted to rescind budget, transfer cash, and appropriate funds for this new SRF; and

**WHEREAS**, the City requires a new Special Revenue Fund to receive revenue and administer program services and related expenses;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** A new Fund is hereby established in the Human Services Special Revenue Fund Series, Accounting No. 13000, the “Border Crisis Response” Fund, Accounting No. 13809, for the purpose of providing support to programs and services for migrants and asylum seekers arriving in Denver from other countries.

**Section 2.** Monies received from cash transfers from the General Fund and other city funds and other sources of program income for the Border Crisis Response Special Revenue Fund shall be deposited into the Treasury of the City and credited to Fund No. 13000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

**Section 3.** Expenditures are hereby authorized for the “Border Crisis Response” Fund, Accounting No. 13809, to be expended by the Executive Director of the Department of Human

1 Services. Authorized expenditures for Accounting No. 13809 include but are not limited to personnel,  
2 services and supplies, equipment, and other costs related to providing services to people arriving in  
3 Denver from other countries. This fund is revenue based and non-lapsing.

4 **Section 4.** The Chief Financial Officer of the City and County of Denver is hereby authorized  
5 and directed to make such book and record entries and to do such other things as may be  
6 necessary to accomplish the purposes of this Ordinance.
