David Kim is a physician with 30 years of public health experience: first as a medical epidemiologist at the Centers for Disease Control and Prevention (CDC), then as the Director (as delegated by the Assistant Secretary for Health) of the National Vaccine Program, Department of Health and Human Services. Complemented by his duties as a medical officer in the U.S. Public Health Service, David developed expertise in infectious disease epidemiology, disease surveillance, outbreak investigations, immunization, immigrant and refugee health, and emergency preparedness and response. To ground his work that public health is about people, David saw patients in HIV, TB, and refugee health clinics throughout his career. David also worked in and collaborated with state health departments to ground his work as a “Fed”, and took care to include professional organizations, advocacy groups, and industries in health policy discussions. David graduated from Lincoln High in Denver, earned BA and MA from Colorado College, and MD from the University of Colorado School of Medicine. He completed internal medicine residency at the University of Rochester and Epidemic Intelligence Service fellowship at CDC. He has adjunct faculty appointments at the University of Maryland School of Medicine and the Colorado School of Public Health.
