**A BILL**

6 **For an ordinance designating certain properties as being required for public use**  
7 **and authorizing use and acquisition thereof by negotiation or through**  
8 **condemnation proceedings of fee simple, easement and other interests,**  
9 **including any rights and interests related or appurtenant to properties**  
10 **designated as needed for the 51st Avenue: Logan Street to Emerson Street**  
11 **project.**

12 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

13 **Section 1.** That the Council hereby designates the following properties situated in the City  
14 and County of Denver and State of Colorado as being needed for public uses and purposes by the  
15 City and County of Denver, a municipal corporation of the State of Colorado:

36 **Section 5.** That the Council finds and determines that the Denver Department of

1 Transportation and Infrastructure and federal and state agencies may find the need to alter the  
2 nature of the property interests or the legal descriptions of the properties referred to in this Ordinance  
3 and may continue to do so in order to meet the needs of the Project. Council authorizes the Mayor,  
4 including his duly authorized representatives, in accordance with applicable federal, state, and City  
5 laws and rules and regulations adopted pursuant thereto, to acquire the property as the property  
6 interests and legal descriptions are altered in accordance with the means authorized in this  
7 Ordinance.

8 **Section 6.** That the Council hereby finds and determines that to improve the safety and  
9 operation of pedestrians, bicycles and vehicles in the vicinity of the Project, it may be necessary to  
10 rebuild, modify, remove, and relocate existing access points to streets located in the vicinity of the  
11 Project.

12 **Section 7.** That the Council authorizes the City to acquire through negotiated purchase or  
13 condemnation all or any portion of any property interest as needed for the 51<sup>st</sup> Avenue project from  
14 Logan to Emerson. This includes easement interests, access rights, improvements, buildings,  
15 fixtures, licenses, and permits as part of the Project.

16 **Section 8.** That the City Council hereby finds and determines that the Project is necessary  
17 for the health, safety, and welfare of the public.
