**A BILL**

**For an ordinance making supplemental appropriations from the General Contingency Fund to Departments;**

**WHEREAS**, the Fire Department needs budget adjustments due to providing fire services to the City of Englewood which will be reimbursed with revenue; and

**WHEREAS**, the Office of Economic Development needs budget adjustments due to business incentives for the United Airlines flight training center and a Costco business center;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred to the General Fund:
