6. **General description/background of proposed ordinance including contract scope of work if applicable:**

Re-bid of the Hampden and Havana (State Highway 30) Pedestrian Safety Connections Project from Dayton Street to approximately 1300 feet north of Dartmouth Street. The project consists of the construction of the following estimated quantities of work: 5,900 linear feet of 10-foot wide sidewalks by 6 inches thick; 900 linear feet of 20-foot wide multi-use path and maintenance road by 6 inches thick; 2000 square feet of rockery “dry stack” wall; 750 linear feet of metal pedestrian railing; 4,200 cubic yards of embankment material (embankment material available from Kennedy Golf Course); minor storm drainage improvements (2 inlets, 2 manholes, 190 linear feet of reinforced concrete pipe, and 5 stone headwalls; 4 expanded and improved bust stops by adding concrete platforms for future benches and shelters; 4 acres of irrigation system for 4 acres of landscaping improvements (seeding for turf and natural areas, shrubs, plants, boulders and trees); and miscellaneous work such as removals, signing, markings, concrete curb ramps, hot mix asphalt patching, erosion control, surveying, landscape maintenance and traffic control. Several staging areas provided for construction.
