4 **A RESOLUTION**

5 **Laying out, opening and establishing as part of the City street system a parcel**
6 **of land as a public alley bounded by East 14th Avenue, North Steele Street, East**
7 **Colfax Avenue and North Adams Street.**

8 **WHEREAS**, the Executive Director of Public Works of the City and County of Denver has
9 found and determined that the public use, convenience and necessity require the laying out, opening
10 and establishing as a public alley designated as part of the system of thoroughfares of the
11 municipality that portion of real property hereinafter more particularly described, and, subject to
12 approval by resolution has laid out, opened and established the same as a public alley;

13 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

14 **Section 1.** That the action of the Executive Director of Public Works in laying out, opening
15 and establishing as part of the system of thoroughfares of the municipality the following described
16 portion of real property situate, lying and being in the City and County of Denver, State of Colorado,
17 to wit:

18 **PARCEL DESCRIPTION ROW NO. 2016-DEDICATION-0000260-001:**

19 Parcels acquired for the purposes of a public alley by the City and County of Denver through Final Decree, recorded on
20 the 1st day of May, 1916, at Book 2591, Page 363 at the City and County of Denver Clerk and Recorder's Office, State
21 of Colorado, more particularly described as follows:

22 The east 6.00 feet of Lots 1 through 23 inclusive, and the west 6.00 feet of Lots 24 through 46 inclusive, all in Block
23 202, CAPITOL AVENUE SUBDIVISION, recorded on the 28th day of February, 1887, at Book 4, Page 19 at the Arapahoe
24 County Recorder's Office, State of Colorado.

25 be and the same is hereby approved and said real property is hereby laid out and established and
26 declared laid out, opened and established as a public alley.


27 **Section 2.** That the real property described in Section 1 hereof shall henceforth be a public
28 alley.


