A BILL

For an ordinance making a rescission from General Fund Contingency, making an appropriation in the General Fund, and making a cash transfer to the General Government Special Revenue Fund.

WHEREAS, the City and County of Denver uses the Risk Management Special Revenue Fund to pay deductibles for various insurance programs and to cover replacement costs where the City is self-insured, such as City-owned vehicles involved in auto accidents; and

WHEREAS, the Special Revenue Fund’s expenditures in 2019 were uncharacteristically high due to extreme weather, an increase in property insurance deductibles including the general deductible and the special hail deductible, and the replacement of large vehicles; and

WHEREAS, the projected cash balance of the Risk Management Fund in 2020 will not be sufficient to fund the \$1.4 million in replacement police vehicles and cover the average cost of annual property damage; and

WHEREAS, when the revenue from insurance reimbursements and subrogation claims are not enough to cover the obligations of the Special Revenue Fund, the General Fund must cover the variance;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred to the General Fund:

Section 2. From the General Fund, Accounting No. 01010, out of monies rescinded from Section 1 not otherwise appropriated and in addition to amounts heretofore appropriated by

1 Ordinance No. 1193, Series of 2019, and any supplemental appropriations or rescissions, there is
2 hereby appropriated to the appropriation accounts hereinafter designated the amount of money
3 following such designation, to be expended for the purposes and upon the authorizations in said
4 Ordinance set forth:


