A BILL

For an ordinance making appropriations to the Wastewater Management Enterprise Fund.

WHEREAS, Wastewater Management is requesting an appropriation from the Urban Drainage and Flood Control District's (UDFCD) contribution to support the construction of drainage and flood control improvements for the Glenbrook Detention Basin;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From the Wastewater Management Enterprise Fund, Accounting No. 72000, out of monies not otherwise appropriated and in addition to amounts heretofore appropriated by Ordinance No. 1032, Series of 2016, and any supplemental appropriations or rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the amount of money following such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:
