Business, Workforce & Sustainability

- BR13-0320 Approves a \$782,200 capital equipment purchase from Daktronics for exterior signage and 2 new digital LED marquees installed on each end of the Denver Coliseum building with visibility from both directions of I-70 and the replacement of the "Denver Coliseum" letters with internal illumination.

Government & Finance

- BR13-0321 Adds \$1,125,000 and five years to the contract with West Publishing Corp (CE85004-02) for electronic legal research for the City Attorney's Office.
- BR13-0324 Adds \$3,000,000 to the Front Range Wholesale Restaurant Master Purchase Order (0181A0211) for food for the two Denver jails and Family Crisis Center for a total of \$6,000,000 through March 1, 2015 .
- BR13-0325 Adds \$3,000,000 to the Sysco Food Services Master Purchase Order (0181A0111) for food for the two Denver jails and Family Crisis Center for a total of \$5,000,000 through March 1, 2015.

Health, Safety, Education & Services

- BR13-0323 Approves a fifth amendment to the Xerox State and Local Solutions contract to extend the term of the agreement by 18 months through December 31, 2014 and to add \$2,051,550 for continued services related to the Photo Radar Speed Enforcement System (CE-81107-05).

Land Use, Transportation & Infrastructure

- RR13-0326 Grants a revocable permit to the Board of Directors of the Auraria Higher Education Center to encroach into the public right-of-way with 18 banner poles and 8 planters along Larimer St. between 14th St. and

Southbound Speer Blvd. in Council District 9.

- BR13-0328 Revokes the revocable permit granted by Ordinance # 278, Series of 1989, and Ordinance # 798, Series of 1989, to the Department of the Army Corps of Engineers to encroach into the public right-of-way with a 16-inch water line and meters at Montview Blvd. and Yosemite St. in Council District 11.
- BR13-0329 Revokes the revocable permit granted by Ordinance # 11, Series of 2005, to Denver Public Schools to encroach into the public right-of-way with a remediation system consisting of four 1-inch pipes and two 5-inch pipes at 2880 W. 8th Ave. in Council District 9.
- BR13-0330 Approves a \$2,456,345 contract with TruStar Energy LLC for the design/build construction of the Compressed Natural Gas (CNG) facility at City's Central Platte Campus (201211045).
- BR13-0331 Extends until April 21, 2017, the contract with Colorado Rockies Baseball Club, Ltd., which allows the Denver Metropolitan Major League Stadium District the authority to maintain improvements constructed by the District; allows Public Works to receive revenue from meter sacking; and authorizes the contracting of off-duty Denver police officers (XC51022-2).

Routine, non-controversial requests for ordinances that are not substantive policy changes may be placed on Consent Agendas for Council Committees each week with the approval of Committee chairs. Councilmembers receive the consent agendas for review and have until Thursday at noon to request that an item be scheduled for Committee discussion. If approved, items are placed on the Mayor-Council agenda the following week. This document outlines the items that were placed on consent agendas this week.
