## *Narrative - Reason for Request - 4211 Hooker St.*

We were informed by Denver Zoning that we have to rezone our property. Currently, our house is zoned as a 'PUD'. Denver Zoning is telling us that we have to update our zoning to U-SU-C, CO-6 which will bring this property into alignment and consistent with the neighborhood.

## *Consistency with Adopted Plans*

- Comprehensive Plan 2040
- Blueprint Denver (2019)

# *Comprehensive Plan 2040*

The proposed rezoning is consistent with many of the adopted *Denver Comprehensive Plan 2040* strategies, which are organized by vision element.

The proposed rezoning would allow for additional housing options near transit within an established neighborhood, consistent with the following strategies in the Equitable, Affordable and Inclusive vision element:

- Equitable, Affordable and Inclusive Goal 1, Strategy A - Increase development of housing units close to transit and mixed-use developments (p. 28).
- Equitable, Affordable and Inclusive Goal 2, Strategy B - Create a greater mix of housing options in every neighborhood for all individuals and families (p. 28).

The proposed map amendment would allow for compatible infill development in an established neighborhood and near transit, consistent with the following strategies from the Environmentally Resilient vision element:

- Environmentally Resilient Goal 8, Strategy A - Promote infill development where infrastructure and services are already in place (p.54).
- Environmentally Resilient Goal 8, Strategy C - Focus growth by transit stations and along high- and medium-capacity transit corridors (p. 54).

# *Blueprint Denver*

## Urban

Small multi-unit residential and mixed-use areas are typically embedded in 1-unit and 2-unit residential areas. Block patterns are generally regular with a mix of alley access. Buildings are lower scale and closer to the street.

## Residential Low

Predominantly one-and two-unit, though many areas are mostly one-unit. Includes Accessory Dwelling Units. In some contexts, some higher-intensity residential uses may be mixed throughout. Neighborhood-serving retail may be found in some key locations. Buildings are predominantly low-scale houses and duplexes. Setbacks and lot coverage vary across neighborhood contexts.

## Growth Areas Strategy

All other areas of the city that anticipates 20% of housing and 10% employment growth (p. 51). Most growth is guided to regional centers, community centers and corridors, select districts and high and medium-high intensity residential areas. Other areas of the city are still expected to see some growth, however more limited.

# *Blueprint Denver 2019*

“Increase the development of affordable and mixed-income housing, particularly in areas near transit, service and amenities” thereby improving access to the supply of housing equitably to all Denver residents.

This rezoning supports the city’s goals to reduce climate impacts by enabling additional housing near transit, reducing auto-dependency and greenhouse gas emissions.

“Rezone properties from the Former Chapter 59 zoning code so that the entire city is covered by the DZC, including continuing to incentivize owners to come out of the old code”
