A BILL

For an ordinance authorizing expenditures in the Human Services Special Revenue Fund based on a letter of intent from United States of America to award funding for the “SPC – Housing First FY12-13” program.

WHEREAS, the United States Department of Housing and Urban Development (HUD) awards Shelter Plus Care (SPC) grant funds to the City and County of Denver annually; and

WHEREAS, HUD has sent a letter stating their intent to provide SPC—Housing First FY12-13 grant funds to the Denver Department of Human Services; and

WHEREAS, the City and County of Denver has given due consideration to said letter of intent to fund, a copy of which is duly filed with the City Clerk, Filing No. 12-0097;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. Expenditures are hereby authorized from the Human Services Special Revenue Fund, Accounting No. 13000, the amounts of money in the following tabulation to be expended for the purposes and upon the authorizations in said Ordinance set forth:

The foregoing authorization will fund rental assistance for chronically homeless men with substance abuse, mental illness, or coexisting disorders. Authorization for expenditures will cover the period from April 1, 2012 to March 31, 2013. The foregoing authorization is for 25% of the amount indicated in the Letter of Intent (LOI) to Fund from HUD for the SPC—Housing First program.
