Newcomer Snapshot



Ġì

- Numbers are decreasing
 - <2,400 newcomers currently in shelter
 - Down from 4,500 newcomers on Jan. 31
- 300 newcomers arrived in past two weeks
 - > Average of 22 new arrivals per day
 - 6 buses from Texas in Feb (40 in Jan, 140 in Dec)
- 10 facilities currently activated, with plans to close some

Shelter Transition Plan

Currently Operating:

- 7 non-congregate hotel shelters
- 1 congregate shelter, with 1 on standby if needed
- 1 transitional housing facility

Consolidation and Closure Plan

- Close four hotel shelters by first week of April
- Standby congregate shelter comes offline on March 30



Discharge Process

- Our community partners are providing individualized support for each family. Upon discharge some move to transitional housing, some long-term housing, some travel onward.
- We have several organizations (13 navigators) tracking where families/individuals are going once discharged. Part of the mini-grant is to share this info at the end of March.
- Thanks to our community partners, we have not seen a large uptick in encampments.



Work Authorization Clinic Update

- 600 applications submitted through 2/23/24
- Eligibility screenings at newcomer shelters were key to preparing applicants, along with community volunteers – especially Spanish-speakers who can help with translation/interpretation, and large spaces like the Webb's atrium
- Lutheran Family Services, JAMLAC, Catholic Charities, AILA CO, Haven of Hope, Colorado Lawyers Committee have been great partners
- Based on current USCIS adjudication times, applicants should receive work permit cards in 2-3 weeks from date of the clinic
- Additional clinics scheduled through the beginning of March, anticipate assisting 700 more people.




Case Management Update

- This has been a huge success!

- Assisting newcomers with rapid case management includes onward travel and resources for housing, education, workforce training, legal assistance, food, and others as necessary
- Initial mini-grants are through April 1, 2024
