Please accept this letter of support for the historic district application for the Tilden School for Teaching Health. This small district contains only a few structures, but represents an early and interesting piece of Denver history, highlighting a lesser-known reason Denver became a popular place to live, the healthy climate.

Dr. John Henry Tilden founded the school and operated it from 1916 to 1931. He believed a healthy diet and plenty of fresh air and sunshine were the keys to good health. He incorporated the earlier Bosler House, now a restored home, as his administration building and hired prominent architect Harry Edbrooke to design the hospital structures on the adjacent lots. The Tilden School closed after the great Depression set in, and the buildings went through a series of transition uses until recently, when they were converted for residential use.

The buildings are already listed on the National Register of Historic Places, but this is an honorary designation and does not protect them from demolition. For this reason the owners in the buildings have partnered to submit this nomination, so that the structures remain related and intact for future generations.

We appreciate the efforts the owners and residents have undertaken to learn about the designation process, inform their neighbors, and prepare this application for your consideration and for the consideration of Denver City Council. It is a worthy place with special meaning for North West Denver.

We are writing in enthusiastic support of the Denver Landmark application for the Tilden School for Teaching Health Historic District. In 1995 we studied the buildings and history associated with this historic property as part of a successful project to list it in the National Register of Historic Places. In the course of preparing the nomination we documented the architecture and history associated with the school, a place with an amazing story relating to the history of healthcare in Denver and with an exceptional collection of buildings. The Colorado State Review Board, composed of professionals from around the state, voted overwhelmingly in favor of forwarding it for listing.


The Tilden School qualifies under all three significance criteria: A, history; B, architecture; and C, geography. As noted in the landmark application the buildings of the district are between 98 and 137 years old. Under Criterion A, the district is associated with the historical development of the city and the growth of medical sanitariums as an important sector of the local economy. The Tilden School is also associated with the national trend of private sanitariums offering innovative medical treatments. The property is strongly associated with Dr. John Henry Tilden, who founded the medical complex and developed its methods of improving people's lives.

The Tilden School is significant for its architecture displaying distinguishing characteristics of the Italianate, Classical Revival, and Craftsman styles to create medical buildings that fit in with, yet were distinguished from, the residential architecture of the neighborhood. The buildings included large porches and windows believed at the time to benefit patients by providing large doses of Colorado's bright sunshine and fresh air. The district includes buildings representing important works of master Denver architect Harry W. J. Edbrooke. The district also portrays the environment of a group of people or physical development of an area in an era of history characterized by a distinctive architectural type—the private medical sanitarium of the early twentieth century. The buildings are significant for the type and methods of construction displayed, which represent early twentieth century theories for patient treatment.


The Tilden School is significant for its geography, having a prominent location and constituting an established, familiar, and orienting visual feature of the contemporary city. Standing on the west side of Grove Street, just across from Highland Park, the large and distinguished brick buildings of the school contrast visually with the comparatively small houses of the area; their differences are highlighted by the landscaping of the complex. The Tilden School lends distinction to one of the important gateways into the West Highland neighborhood.

We urge you to approve and forward the application for Tilden School for Teaching Health, one of Denver's outstanding historic properties, to the City Council for designation as a Denver Landmark.

Dear Landmark Commissioners,

I urge you to support the proposed landmark district encompassing the former buildings of the Tilden School for Teaching Health in West Highland. It is eligible because the site fulfills all three of the criteria for designation. It is architecturally significant, the work of Harry W.J. Edbrooke. It is a recognizable landmark, forming the western “wall” of Highland Park. And it is historically significant for its connection to Dr. John Henry Tilden, who had a national following in the early part of the 20th century. Not only did patients come to the school from all over the country, but his magazine, *Philosophy of Health* (I have a copy in my collection, if you are interested in seeing it) had nationwide circulation. It is also emblematic of Denver’s one-time status as a health Mecca—it’s not a tuberculosis sanitarium, like the long-lost Oakes Home on 32nd & Decatur, or the long-lost Agnes Phipps Memorial Sanitarium at 6th & Quebec, but it is a survivor of the period when Denver was thought of as a place for people to recover their health. Tilden’s teachings were controversial, and probably scientifically fallacious, but that does not change the campus’s importance to Denver’s “health story.”

I am a near neighbor—I can see the building now called Fairview Place Condominiums from my back porch, and I have walked past the buildings thousands of times in my eighteen years of living at this address.

I am also a historian, the author of six published books on Denver historical subjects (with a seventh, *A History Lover’s Guide to Denver*, forthcoming next spring). In my second book, *Northwest Denver*, I wrote about the Tilden School on pages 57, 62 and 63.

Stettner Letter of Support for Tilden School for Teaching Health Historic District  
November 4, 2019

This is a letter in support of designating the Tilden School for Teaching Health as a Historic District.

I am a member of the Stettner family, owners of a condominium in the Main Building of the Tilden School District, known in the neighborhood as Fairview Lofts. As the current chair of the Steamboat Springs Historic Preservation Commission (where I live full time) and past President/ longtime board member of Colorado Preservation Inc. I am keenly aware of the financial benefits and prestige brought by historic landmark designation. After we purchased the Fairview Lofts condo in 2014, I became aware of the rich history of the building, the Tilden School, and the neighborhood. The challenges with the Bosler House, already a Denver Landmark, were being resolved, and as new neighbors, we were thrilled to see the building saved and restored.

Inspired by rescue of the Bosler house and the fact that 2019 is the Centennial of the Harry Edbrook designed Fairview Lofts building, a group of Fairview Loft owners and neighbors launched the effort designate our building as a Denver Landmark. The nomination was first discussed at the 2017 Fairview Lofts Annual Meeting, again at the 2018 Annual Meeting, and at numerous board meetings in between. No one voiced any opposition. We have sent fliers to the owners about the project and sent them the Wikipedia link (not to overwhelm them with the entire document) so they know about the history of the property.

For nearly a year our team, Paul Cloyd, Joan Bolduc, Marilyn Quinn, Fran Trujillo, and I, researched and prepared the Fairview Lofts nomination and were prepared to submit it to Denver Landmarks last November. Then it was suggested to expand the designation to be a Historic District and to include the rest of the original Tilden School Campus: the Bosler House, the adjoining 1916 Patient Apartments, and the current Heather Grove Veterans Home. Regrettably, the Veterans Home owners did not wish to participate, but we hope they will do so in the future.

The nomination for the district was submitted and reviewed by the Landmarks staff earlier this year, slightly revised, and deemed ready for review by the Commission in September. Landmarks staff scheduled a public meeting to discuss the nomination at the Woodbury Library several weeks ago. City Council member Amanda Sandoval attended, as well as Landmarks and Planning department staff. The Fairview Board, Steve and Jan Davis, owners of the Bosler House, and a half dozen Fairview owners were there as well. Good questions, and NO opposition. Four of the original condo owners who have lived there since 1996 (when the building was converted into condominiums) are very supportive of the nomination. The current HOA board has endorsed the effort as well.

Thank you for your considering the Landmark Designation of this important part of Denver's history.
