8 **For an ordinance establishing a new Fund in the Grants and Other Money Projects**  
9 **Fund Series for the “Mile High Flood District Green Infrastructure Guidelines IGA”**  
10 **program and authorizing appropriations in the new fund.**  
11

12 **WHEREAS**, the City recently entered into an agreement with the Mile High Flood District, which  
13 allows the city to accept funds from the Mile High Flood District for fifty percent of the costs of a city-  
14 sponsored project to develop the second edition of the Ultra Urban Green Infrastructure Guidelines;  
15 and

16 **WHEREAS**, per said agreement, the Mile High Flood District will reimburse the City for up to  
17 \$100,000 of project costs; and

18 **WHEREAS**, the City requires a new Capital Project Fund and appropriation for this purpose;

20 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**  
21 **DENVER:**  
22

23 **Section 1.** A new fund is hereby established in the Grant and Other Money Projects Fund,  
24 Accounting No. 38000, “Mile High Flood District Green Infrastructure Guidelines IGA” Fund,  
25 Accounting No. 38435, for the purpose of accounting for the receipt of expenditure of capital program  
26 dollars.

27 **Section 2.** Monies received from the Mile High Flood District, including payments for  
28 reimbursements, and other sources of program income shall be deposited into the Treasury of the  
29 City and credited to Special Fund No. 38000, which is set forth and described in Section 20-18 of  
30 the Revised Municipal Code of the City and County of Denver.

31 **Section 3.** Expenditures are hereby authorized for the “Mile High Flood District Green  
32 Infrastructure Guidelines IGA” Fund, Accounting No. 38435, to be expended by the Executive  
33 Director of the Department of Transportation and Infrastructure. Authorized expenditures for

1 Accounting No. 38435 include capital projects and capital improvements. This is an appropriated,  
2 non-lapsing fund.

3 **Section 4.** That it be and is hereby found and determined that the budget summary of said  
4 program, to be expended by the Executive Director of the Department of Transportation and  
5 Infrastructure, is as follows:

8 The foregoing authorizes expenditures for the Mile High Flood District Green Infrastructure  
9 Guidelines IGA Program.

11 **Section 5.** The Chief Financial Officer of the City and County of Denver is hereby authorized  
12 and directed to make such book and record entries and to do such other things as may be necessary  
13 to accomplish the purposes of this Ordinance.
