A RESOLUTION

Laying out, opening and establishing as part of the City street system a parcel of land as East 9th Avenue, located at the intersection of East 9th Avenue and North Clermont Street.

8 **WHEREAS**, the Executive Director of the Department of Transportation and Infrastructure of
9 the City and County of Denver has found and determined that the public use, convenience and
10 necessity require the laying out, opening and establishing as a public street designated as part of
11 the system of thoroughfares of the municipality those portions of real property hereinafter more
12 particularly described, and, subject to approval by resolution has laid out, opened and established
13 the same as a public street;

14 BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

15 **Section 1.** That the action of the Executive Director of the Department of Transportation
16 and Infrastructure in laying out, opening and establishing as part of the system of thoroughfares of
17 the municipality the following described portion of real property situate, lying and being in the City
18 and County of Denver, State of Colorado, to wit:



6 THENCE COINCIDENT WITH THE WEST LINE OF SAID NORTHWEST QUARTER OF THE
7 NORTHEAST QUARTER OF THE SOUTHWEST QUARTER S 00°00'22" E, A DISTANCE OF
8 631.10 FEET TO THE POINT OF BEGINNING;
9 THENCE N 89°58'46" E, A DISTANCE OF 310.02 FEET TO THE WEST RIGHT-OF-WAY LINE OF
10 CLERMONT STREET;

22 declared laid out, opened and established as East 9th Avenue.

23 **Section 2.** That the real property described in Section 1 hereof shall henceforth be known
24 as East 9th Avenue.
