

## Proclamation CP10-0451, Series of 2010 Recognizing Bill Lovingier on the occasion of his retirement

Introduced by Councilmembers Hancock and Linkhart

WHEREAS, Bill Lovingier, Director of Corrections and Undersheriff will be retiring on May 31, 2010 after 32 years of dedicated service to the Denver Sheriff Department and the City and County of Denver; and

WHEREAS, Bill's career began in 1978 as a deputy sheriff at the Denver County Jail subsequently promoting to Sergeant, Captain, Major, Division Chief and finally Director of Corrections a position he has held for the last four years; and

WHEREAS, Bill's immense knowledge of the corrections system comes from having worked in numerous divisions including the Pre-Arraignment Detention Facility, Denver Health Medical Center, Community Corrections/Work Release, Court Services and Civil Division, Internal Affairs and Technology, Support and Special Projects; and

WHEREAS, Among his many accomplishments as the Director of Corrections, Bill has spearheaded creation of Mental Health Transition units which will forever change the way incarcerated people with mental health issues are treated, reacquisition of accreditation from the American Correctional Association, creation of the Prisoner Industry Enhancement Certificate Program, establishment of an objective prisoner classification system and a Jail Management System, and initiation of the "Meds Upon Release Program", as well as the opening of Denver's new state of the art downtown detention facility—the Van Cise-Simonet Detention Center; and

**WHEREAS**, His talents are also well-known among professionals in his field beyond the City borders through his participation in numerous state and national organizations where Bill has been instrumental in advancing the reputation of the Denver Sheriff Department; and

**WHEREAS**, Bill's educational background includes an Associate's Degree in criminal justice from Red Rocks Community College and a Bachelor's Degree in criminal justice from Regis University and he also holds numerous specialized training certifications from local, state and federal organizations; and

**WHEREAS**, Bill and his wife of 38 years, Dixie will soon have more time to enjoy their three wonderful children and six beautiful grandchildren and their passion for bicycling and motorcycling.

## BE IT PROCLAIMED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:
