6. **General description/background of proposed ordinance including contract scope of work if applicable:** Environmental Health, Aviation, Fire and Police rely on Custom Environmental Services, aka "Custom", for their excellent 'on-call' service in collecting and managing hazardous materials and regulated waste. Most recently Public Works/Solid Waste and Parks & Recreation commanded Custom's services for significant projects related to collection and disposal of hazardous items and waste abandoned by transients and persons trespassing on park lands and streets. This recent activity has almost depleted existing contract value while the existing contract term extends into October 2018. The purpose of this amendment is to increase the expenditure value of the current on-call contract with Custom so that the City may continue to avail itself of their hazmat management services throughout the remaining ~27 months of the original contract term.

EXECUTIVE SUMMARY

Custom Environmental Services, Inc.

Custom Environmental Services, Inc., aka "Custom", provides professional on-call services to the City for collection, containment, and disposal of hazardous material and regulated wastes. Custom is one of three on-call hazmat contractors to the City managed through DEH. Since 2013, DPD, DFD, DEH, DIA, and cultural facilities have use Custom for routine spill response, clean-up and hazardous waste disposal. Beginning spring 2016, Public Works (Solid Waste div.) and Parks & Recreation used Custom to provide critical waste pick-up, storage and disposal service connected to clean-up of abandoned items by transient and homeless persons. This recent and on-going work has rapidly depleted the remaining expenditure value of our agreement with Custom. To meet City needs over the remaining 2+ years of the original contract term for both routine hazmat work, highway spill response, and any future abandoned waste clean-up projects, the City's agreement with Custom must be amended in value.
