A BILL

For an ordinance authorizing a capital equipment purchase from the “American Rescue Plan Act (ARPA)” Grant Fund to support the Department of Housing Stability (HOST).

WHEREAS, The Department of Housing Stability is seeking approval to purchase a boiler for a city-owned, non-congregate family shelter to meet the shelter's high-capacity use needs; and

WHEREAS, said purchase will come from the HOST “ARPA” Program award, previously appropriated under GR00002667; and

WHEREAS, said capital equipment items exceed the \$50,000 threshold requiring City Council approval, per the Denver Revised Municipal Code; and

WHEREAS, this bill request authorizes the purchase of said boiler;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From the General Government Special Revenue Fund Series, Accounting No. 11011, the Executive Director of the Department of Housing Stability, or duly authorized representatives, is hereby authorized to purchase or acquire the following capital equipment:

Section 2. The Chief Financial Officer of the City and County of Denver is hereby authorized and directed to make such book and record entries and to do such other things as may be necessary to accomplish the purposes of this Ordinance.
