This allows Morrison to expand the current water treatment plant located at Red Rocks Park to comply with new state mandated regulations for municipal water treatment facilities. The amendment changes the boundary and adds the construction and operation of a clear well facility as permitted facilities. This water treatment plant provides water to the CCC Camp and DPR Mountain Parks Headquarters as well as the Amphitheatre at Red Rocks.
