**SUBJECT:** Department of General Services – MFP CO II, LLC and MSP Master Tenant I, LLC lease agreements for solar power generating facilities scattered Citywide

### **Purpose of Amendment**

The purpose of the thirteen amendments to the lease agreements with MFP CO II, LLC and MSP Master Tenant I, LLC were needed to address needed repair and maintenance service to the roofs which currently house solar power on various city facilities. The original lease agreements between the City and County of Denver and the contractors did not clearly state each parties' responsibilities in relation to roof repairs. The amendments revise and clarify the roles and responsibilities of each party as they relate to roof repairs. The lease agreements for the solar power generating facilities are one important strategy to achieving the city's renewable electricity goals and compliance with Energize Denver Building Performance Ordinance.

### **Contract Description**

There was a contract dispute so both parties entered negotiations and reached an agreement on March 29, 2022. The dispute between the parties resulted from roof leaks that occurred at multiple solar power generating sites and who was responsible for the roof repairs. The city identified 4 locations that have substantial roof leaks. General Services is working in conjunction with the Department of Transportation and Infrastructure to identify and determine which sites require roof repair and are primed and ready to do the work as soon as possible.

Although only 4 sites have been identified having substantial damage and are in need of immediate repair, the remaining sites are also in need of repair and maintenance. If additional sites are identified as needing repair, the amendment clearly outlines the roles and responsibilities of each party. The amendments also provide a percentage breakdown of cost for each party is responsible for the removal, storing and reinstallation of the solar panels at each generating facility after the roof repairs are completed.

### **Generating Facility Locations**

Solar energy generating sites under contract with MFP CO II, LLC and MSP Master Tenant I, LLC are scattered across the City. The following list outlines the contractor, facility name and address of solar generating site, and contract numbers associated with each site that are being amended.
