**A BILL**

**For an ordinance relinquishing the Permanent Non-Exclusive Easement, in its entirety, recorded with the Denver Clerk & Recorder at Reception No. 2017094266, located near East Bolling Drive, Green Valley Ranch Boulevard, North Memphis Street and North Airport Way.**

**WHEREAS**, the Executive Director of the Department of Transportation and Infrastructure of the City and County of Denver has found and determined that the public use, convenience and necessity no longer requires the Permanent Non-Exclusive Easement, and subject to approval by ordinance, has relinquished the same;

**Section 1.** That the action of the Executive Director of the Department of Transportation and Infrastructure in relinquishing the Permanent Non-Exclusive Easement recorded with the Denver Clerk & Recorder at Reception No. 2017094266, be and the same is hereby approved and that the Permanent Non-Exclusive Easement is hereby relinquished.
