**5. General description or background of proposed request. Attach executive summary if more space needed:**

The outside counsel contract with law firm SGR, LLC needs to be extended to allow the firm to continue litigating civil rights cases on behalf of Denver and its employees that are ongoing. These cases include the following: Montoya v. Denver, et al.; Estate of Finn v. Denver, et al.; Jordan v. Dodge; and Skaggs v. Denver. SGR, LLC has been used by Denver as outside counsel on conflict cases and for overflow work for 20 years. The firm has a unit of multiple attorneys who specialize in civil rights defense litigation. There are only a handful of Colorado law firms that employ attorneys who specialize in this area of law. Civil Litigation needs access to multiple firms for outside counsel work, especially when a case has multiple defendants, and actual or potential conflict issues are present. SGR charges a reasonable rate for outside counsel work. Attorneys at SGR, LLC are also very familiar with Civil Litigation's work having previously defended some of the City's most difficult civil rights cases including Estate of Emily Rice v. Denver and Estate of Marvin Booker v. Denver, et al.
