DEN JANITORIAL PROGRAM OVERVIEW



- DEN unbundled the current large janitorial contract to deliver high quality janitorial services and increase opportunity for small business guided by DENs commitment of Service to Our Airport Patrons
- DEN has decided to execute four new janitorial contracts assigned to the following areas:
 - Main Terminal, Airport Office Building (AOB), and related areas within the terminal facility
 - Concourse A, B, and C, including the Airfield Outlying Buildings
 - Trash/recycling rooms, trash/recycling compactor rooms, waste triturator rooms, and loading dock areas located at the A, B, and C Concourses
 - Food courts located on concourse A, B and C

- Purpose: To provide janitorial services for the Main Terminal, Airport Office Building (AOB), and related areas within the terminal facility at Denver International Airport

TERMINAL & AOB CONTRACT OVERVIEW



- Cleaning services in public and non-public restrooms, City offices, TSA Checkpoints, TSA Administration Areas, public and non-public Federal Inspection Service (FIS) areas, stairwells, conveyance equipment, floor care, and carpet care.
- Contract scope and pricing is inclusive of management, staffing, equipment and chemical supply.
- Incorporation of autonomous cleaning equipment.
 - Hard floor care and carpet care
 - The autonomous equipment will allow custodial staff to focus on detailed cleaning services
- Flexibility to scale labor to meet the airports desired level of cleanliness and expand scope of services.
- Flagship will retain current janitorial staff in compliance with Denver Municipal Code Article 11 – Worker Retention.
- Wages are subject to the prevailing wage and minimum wage ordinance.
- Flagship was selected out of thirteen proposals received.

- Cleaning services include public and non-public restrooms, City offices, TSA Administration Areas (A Concourse), public and non-public Federal Inspection Service (FIS) areas (A Concourse), stairwells, passenger loading bridges, exterior patios, pet relief rooms, conveyance equipment, floor care, and carpet care.
- Contract scope and pricing is inclusive of management, staffing, equipment and chemical supply.
- Cleaning locations include airfield outlying buildings.
- Incorporation of autonomous cleaning equipment.
 - Hard floor care and carpet care
 - The autonomous equipment will allow custodial staff to focus on detailed cleaning services
- Flexibility to scale labor to meet the airports desired level of cleanliness and expand scope of services.
- SBM will retain current janitorial staff in compliance with Denver Municipal Code Article 11 – Worker Retention.
- Wages are subject to the prevailing wage and minimum wage ordinance.
- SBM was selected out of fourteen proposals received.

- Purpose: To provide janitorial services for the trash/recycling compactor rooms, trash/recycling rooms, waste triturator rooms, and the loading dock areas located at the A, B, and C Concourses

COMPACTOR/TRITURATOR OVERVIEW



- Cleaning services for various waste compactor rooms, triturator rooms, concourse ramp vestibules, and adjacent space cleaning services.
- Dedicated cleaning staff on first, second, and third shift & dedicated managerial oversight.
 - The Contractor will be responsible for maintaining cleanliness in all assigned areas
 - Services include, pressure washing, sweeping, litter pick up, hard floor care, and pallet pick up
- Contract scope is inclusive of equipment and chemical supply.
- Staffing is based on the Contractors work plan to always maintain the areas of responsibility clean.
- Flexibility to scale labor to meet the airports desired level of cleanliness and flexibility to expand scope of services.
- Wages are subject to the prevailing wage and minimum wage ordinance.
- Kleen-Tech was selected out of five proposals received.

- Term: Three years with two one-year options to extend
- Purpose: To provide janitorial services for the food courts located on concourse A, B and C at Denver International Airport

Concourse Food Court Contract Overview



- Cleaning and sanitation services for the A, B and C food courts.
- Dedicated custodial staff on first, second, and third shift & dedicated managerial oversight.
 - A minimum of 2 custodians per shift, with an opportunity to increase as deemed necessary to ensure clean food courts and passenger traffic.
- Hard floor cleaning services.
 - Incorporation of autonomous cleaning equipment
 - The autonomous equipment will allow custodial staff to focus on detailed cleaning services
- Contract scope is inclusive of equipment and chemical supply.
- Staffing is based on the Contractors work plan to always maintain the areas of responsibility.
- Flexibility to scale labor to meet the airports desired level of cleanliness and meet operational demand during peak travel periods. Flexibility to expand scope of services.
- Wages are subject to the prevailing wage and minimum wage ordinance.
- Wayne was selected out of thirteen proposals received.

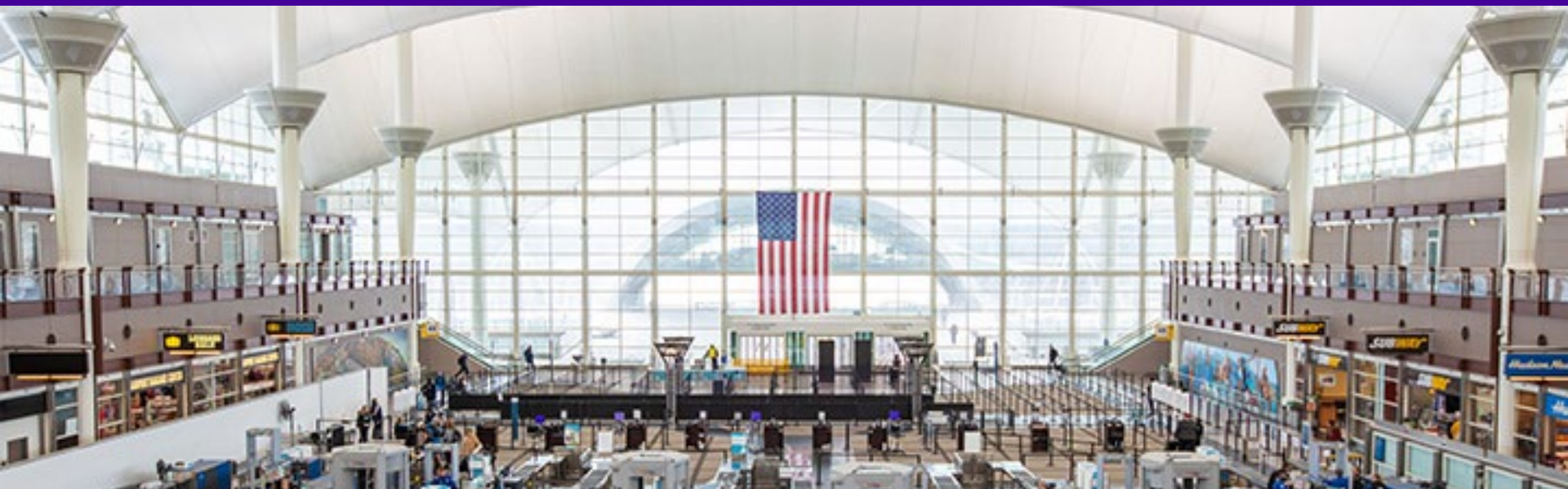
