

IGA with Colorado Department of Transportation (CDOT) for Sheridan Sidewalks: 8th – 10th & Colfax – 17th

BR16-0515

Approves an intergovernmental agreement with the Colorado Department of Transportation (CDOT) through 2021 to transfer \$800,000 in federal funds for new sidewalks and retaining walls in Council Districts 1 and 3.



Project History

Sheridan sidewalks on 8th – 10th and Colfax – 17th have been identified as priorities in several studies/plans:

- CCD Pedestrian Master Plan, 2004
- Sheridan Station Area Plan, 2009
- Urban Land Institute's "Bridging the Lakewood-Denver Divide – Sheridan Station Area" Technical Advisory Panel, 2014
- Sheridan 20-Minute Neighborhood Plan, 2015



Initial DRCOG TIP Funding Request

- As a high priority, Denver applied for DRCOG TIP funding (2016-2020) and the project scored well:
 - Closes a bike/ped gap
 - Provides direct access to transit (new Sheridan LRT station)
 - Touches more than one local government entity
 - Directly serves employment/residences/services
 - Serves environmental justice communities
 - Close proximity to an Urban Center served by transit



Project History (con't)

- However, many bike/ped projects were submitted and project did not rank high enough for TIP funding, but was referred to CDOT for *Transportation Alternatives Program (TAP)* partial funding:
 - CDOT TAP funds = \$800,000
 - Denver Match = \$200,000
 - Total Budget = \$1M for design and partial ROW



Purpose of Intergovernmental Agreements

- Now seeking approval of the IGA for receipt of \$800,000 in federal funding.
- IGA is a grantor / revenue agreement to provide funding, with certain conditions and legal requirements, including committed local match funding.
- Council approval of the IGA is required to set up the budget to receive the federal and local funding, and to encumber funding for the project to proceed.
- Future Council approval of consultant services contract will be needed for the actual project implementation.



Project Summary

- Denver and CDOT shared project
- Construct 5' sidewalk and 5' buffer from 8th to 10th and Colfax to 17th.
- Preliminary Schedule:

North Segment

- No existing sidewalks in this segment, which connects to Sloan's Lake Park
- Project will likely include:
 - Sidewalks
 - Retaining Walls
 - Removal and Replacement of Fencing
 - Partial Takes
 - Full Takes





North Segment - Existing Conditions



Dirt footpath through north segment of project indicates heavy pedestrian use



Sidewalk abruptly ends at RTD bus stop and the edge of Walgreen's property



South Segment

- Existing 3'-5' attached sidewalks in this segment
- Project will likely include:
 - Sidewalks
 - Improvements to Lakewood Gulch Crossing
 - Removal and Replacement of Fencing
 - Retaining Walls
 - Partial Takes
 - Full Takes





South Segment – Existing Conditions



Dirt path leading from 8th Avenue to RTD bus stop



Existing attached sidewalk through south segment of project poses safety issues due to proximity to high volume roadway



Project Benefits

- Closes a gap between existing sidewalk sections to create strong pedestrian connections.
- Improves pedestrian safety throughout the south segment of project.
- Completes pedestrian connections to Sheridan Station from 6th Avenue to 17th Avenue.
- Project coordinates with similar Lakewood project on west side of Sheridan Boulevard.
- Connectivity to Sloan's Lake Park, Lakewood Gulch Park, Sheridan Station (light rail), multiple RTD bus stations, and commercial areas.
- Improvements to the crossing of Lakewood Gulch.
