This is a bill request to approve and update Chapter 18, Article IV of the DRMC that provides for the pay and benefits of the deputy sheriff majors, deputy sheriff division chiefs and the sheriff. This bill request mirrors the negotiated salaries contained in the 2024-2025 Collective Bargaining Agreement (CBA) of the Denver Sheriff Department.

The 2024-2025 Sheriff CBA contains a number of amendments to the current CBA which expired 12/31/2023, including (1) increasing the one-time weapons allowance from \$650 to \$1,000; (2) adding Juneteenth as a recognized holiday; (3) granting up to 4 weeks of paid parental leave for new parents (beginning 1/1/2025); and (4) a 3.0% salary increase effective 1/1/2024, a 4.0% salary increase effective 7/1/2024, a 2.0% salary increase effective 1/1/2025, and a 3.0% salary increase effective 7/1/2025.
