6 **For an ordinance authorizing the City and County of Denver to convey to SID,**
7 **LLC, the City’s interest in a parcel of real estate located at 2942-2944 Welton**
8 **Street.**

9 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

10 **Section 1.** That the Mayor and other proper officials of the City and County of Denver be and
11 they hereby are authorized, empowered and directed in the name and on behalf of the City and
12 County of Denver, to convey to SID, LLC, by Quit Claim Deed, its interest in a parcel of real estate
13 located 2942-2944 Welton Street, in the words and figures contained and set forth in accordance
14 with that form of Quit Claim Deed, filed in the Office of the City Clerk of the City and County of Denver
15 on the 21st day of March, 2022, Filing No. 20220037, and to execute said deed according to the
16 terms thereof.

17 **Section 2.** That the Director, Division of Real Estate, and her designees are hereby
18 authorized, empowered and directed in the name and on behalf of the City and County of Denver,
19 to sign any related documents needed to complete this transaction.
