#### CB11-0821 A bill for an ordinance approving a proposed Purchase Order between the City and County of Denver and Waterblasting Technologies, Inc. for the purchase of one Stripe Hog Waterblasting System Unit for Denver International Airport. (BUSINESS, WORKFORCE & SUSTAINABILITY)

Approves the purchase of one (1) HB8000 Stripe Hog Waterblasting System Unit at a total cost of \$607,537 from Waterblasting Technologies Inc. as part of the Capital Equipment Program to meet requirements of part 139 of FAA runway inspections. The last regularly scheduled Council meeting within the 30-day period is on 12-19-11. The Committee approved filing this bill by consent on 11-10-11.

CB11-0841 A bill for an ordinance approving a proposed Donation and Waiver Agreement between the City and County of Denver and Park Creek Metropolitan District providing for the acceptance of donated artwork, "Staplefield" by artist Walczak & Heiss for Central Park Recreation Center at Stapleton. (BUSINESS, WORKFORCE & SUSTAINABILITY)

Accepts "Staplefield," by Marek Walczak and Wesley Heiss - a suspended interactive light sculpture artwork for the atrium area behind the main reception desk at the Central Park Recreation Center at Stapleton - into the City's permanent art

collection. The Committee approved filing this bill by consent on 11-17-11.

#### CB11-0842 A bill for an ordinance approving a proposed Donation and Waiver Agreement between the City and County of Denver and Park Creek Metropolitan District providing for the acceptance of donated artwork, "Chorus" by artist Thomas H. Sayre for Westerly Creek. (BUSINESS, WORKFORCE & SUSTAINABILITY)

Accepts "Chorus," by Thomas Sayre - a series of nineteen steel-reinforced sculptures was installed in Westerly Park - into the City's permanent art collection. The Committee approved filing this bill by consent on 11-17-11.

#### CB11-0819 A bill for an ordinance making rescissions and appropriations in the General Fund and making a supplemental appropriation from the General Contingency Fund to the Department of Safety. (GOVERNMENT & FINANCE)

Authorizes year-end adjustments to 2011 Department of Safety operating budgets, including rescissions/reappropriations and a supplemental appropriation from the General Contingency Fund totaling \$7,200,000. The Committee approved filing this bill at its meeting on 11-16-11.

#### CB11-0820 A bill for an ordinance approving a proposed Amendatory Lease Agreement between the City and County of Denver and Decatur Place for continued operation of a Temporary Assistance for Needy Families (TANF) office. (GOVERNMENT & FINANCE)

Extends the lease agreement with Decatur Place for three years for continued operation of a Temporary Assistance for Needy Families (TANF) office at an additional cost of \$310,000 increasing the total contract amount to \$710,000. The last regularly scheduled Council meeting within the 30-day review period is 12-19-11. The Committee approved filing this bill by consent on 11-10-11.

## CB11-0903 A bill for an ordinance approving a proposed Agreement for the 2012 Medical Benefit for City and County of Denver employees between the City and County of Denver and Denver Health Medical Plan, Inc. (GOVERNMENT & FINANCE)

Approves an agreement between the City and County of Denver and Denver Health Medical Plan, Inc. for the 2012 Medical Benefit for City and County of Denver employees. The last regularly scheduled Council meeting within the 30-day review period is on 12-19-11. The Committee approved filing this bill at its meeting on 9-14-11.

#### CB11-0835 A bill for an ordinance approving a proposed Amendatory Agreement between the City and County of Denver and Mile High

#### Montessori Early Learning Centers, to extend the term for an additional six (6) months and increase the total amount of compensation for comprehensive Head Start services for program year 2011-2012. (HEALTH, SAFETY, EDUCATION & SERVICES)

Amends the Mile High Montessori Early Learning Centers Head Start Agreement to add \$811,171.15 and to extend the contract through June 30, 2012. The last regularly scheduled Council meeting within the 30-day review period is on 12-19-11. The Committee approved filing this bill by consent on 11-17-11.

#### CB11-0837 A bill for an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and the Colorado Division of Criminal Justice concerning the "Federal Crime Victim Compensation FY11" program and the funding therefor. (HEALTH, SAFETY, EDUCATION & SERVICES)

Accepts the annual VOCA grant from the Colorado Division of Criminal Justice in the amount of \$1,000,000 to augment state funds available to the Crime Victim Compensation Program in the 2nd Judicial District, to assist crime victims in Denver. The last regularly scheduled Council meeting within the 30-day review period is on 12-19-11. The Committee approved filing this bill by consent on 11-17-11.

#### CB11-0817 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Lafarge North America, Inc. for pavement rehabilitation. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Approves a \$929,547.60 contract with Lafarge North America for pavement rehabilitation on 9th Ave. between Lincoln and Ogden in Council District 9. The last regularly scheduled Council meeting within the 30-day review period is on 12-19-11. The Committee approved filing this bill by consent on 11-10-11.

#### CB11-0838 A bill for an ordinance approving a Project Funding Agreement for the Peoria Grade Separation Crossing between Denver, Aurora, and the Regional Transportation District, establishes capital grant fund numbers and appropriates the budget for such grant funds. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Approves an agreement with the Regional Transportation District and Aurora regarding funding for the Peoria Grade Separation project related to the FasTracks East Corridor, establishes capital grant funds and appropriates \$2.5 million (Aurora) and \$20 million (RTD) to the project. The last regularly scheduled Council meeting within the 30-day review period is on 12-19-11. The Committee approved filing this bill by consent on 11-17-11.

#### CB11-0795 A bill for an ordinance amending the classification and pay plan for employees in the Career Service and for certain employees not in the Career Service. (GOVERNMENT & FINANCE)

Changes pay grade for the risk analyst classification from the professional occupational group to the fiscal occupational group to reflect placement in the market and creates a new class of lead animal control investigator to share in administrative tasks for the 18-member unit to reduce the supervisor's span of control. The Committee approved filing this bill by consent on 11-3-11.

#### CB11-0811 A bill for an Ordinance approving an on call technology services agreement by and between the City and County of Denver and Compri Consulting, Inc., in the areas of Generalist, Service Oriented Architecture, Enterprise Integration, Business Intelligence, Data Warehouse and related tasks. (GOVERNMENT & FINANCE)

Approves a two year, on-call technology services agreement for up to \$4,000,000 with Compri Consulting for services in the areas of generalist, service oriented architecture, enterprise integration, business intelligence, data warehouse, enterprise reporting and database administration, geographical information systems, infrastructure and network services, custom web development and PeopleSoft and related tasks. The last regularly scheduled Council meeting within the 30-day review period is on 12-12-11. The Committee approved filing this bill by consent on 11-10-11.

# CB11-0818 A bill for an ordinance making appropriations to pay the expenses of conducting the public business for the year 2012 and for the purposes required by the Charter and by other law. (GOVERNMENT & FINANCE)

Appropriates the 2012 City budget approved by City Council on Monday, November 14, 2011, as required by Charter (commonly referred to as the Long Bill).

CB11-0750 A bill for an ordinance approving a proposed Seventh Amendatory Agreement between the City and County of Denver and Nicoletti-Flater Associates, to add \$204,500.00 for psychological services and to extend the contract for one year. (HEALTH, SAFETY, EDUCATION & SERVICES) Approves a seventh amendment to the agreement (CE-61080-07) between the City and County of Denver and Nicoletti-Flater Associates, to extend the term of the agreement for one year through December 31, 2012 and to add \$204,500 to the contract for psychological services for the Department of Safety. The last regularly scheduled Council meeting within the 30-day review period is on 12-12-11. The Committee approved filing this bill by consent on 10-20-11.

#### CB11-0774 A bill for an ordinance approving a proposed Fiscal Year 2012 Amendment to the Amended and Restated Operating Agreement between the City and County of Denver and the Denver Health and Hospital Authority providing for the amounts to be paid for services by the City and County of Denver and by the Denver Health and Hospital Authority during 2012 and amending other provisions of the Operating Agreement. (HEALTH, SAFETY, EDUCATION & SERVICES)

Approves amendments to the Intergovernmental Agreement between the City and Denver Health for new funding levels and other service adjustments for 2012. The contract allows the City to pay for expenditures in the amount of \$53,492,488 for Denver Health medical services and for the City to receive funds in the amount of \$1,513,164 for City services provided to Denver Health. The last regularly scheduled Council meeting within the 30-day review period is on 12-12-11. The Committee approved filing this bill at its meeting on 11-8-11.

#### CB11-0830 A bill for an ordinance approving a proposed agreement between the City and County of Denver and Robert C. White as Chief of the Denver Police Department. (HEALTH, SAFETY, EDUCATION & SERVICES)

Approves the employment contract with Robert C. White for the position of Chief of Police of the City and County of Denver. The Committee approved filing this bill at its meeting on 11-8-11.

## CB11-0283 A bill for an ordinance vacating a portion of Forest St., at approximately 43rd Ave., with reservations. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Vacates a small portion of Forest St., which is not being used as a street, between 43rd Ave. and railroad right-of-way in Council District 11. The Committee approved filing this bill by consent on 6-16-11.

#### CB11-0719 A bill for an ordinance approving a proposed Fourth Amendatory Agreement between the City and County of Denver and Merrick & Company to extend the term of the contract. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Approves a fourth amendment to the On-Call General Engineering Services Agreement with Merrick & Company to extend it for one year, with one more oneyear option, with a maximum work order amount of \$500,000 and a total amount not to exceed \$2,500,000. The last regularly scheduled Council meeting within the 30-day review period is on 12-12-11. The Committee approved filing this bill by consent on 10-6-11.

#### CB11-0721 A bill for an ordinance approving a proposed Second Amendatory Agreement between the City and County of Denver and American Sign and Striping Company to increase the maximum contract amount and extend the term. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Approves a second amendment to the On-Call Traffic Signage Replacement/Installation contract with American Sign and Striping Company, Inc. to extend one year and add \$200,000, for a new maximum of \$1.4 million. The last regularly scheduled Council meeting within the 30-day review period is on 12-12-11. The Committee approved filing this bill by consent on 10-6-11.

#### CB11-0734 A bill for an ordinance approving a proposed Fourth Amendatory Agreement between the City and County of Denver and Huitt-Zollars, Inc. to extend the term of the contract. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Approves a fourth no-cost amendment to the On-Call General Engineering Services Agreement with Huitt-Zollars to extend for one year, leaving one more one-year option, with a maximum work order amount of \$500,000 and a total amount not to exceed \$2,500,000. The last regularly scheduled Council meeting within the 30day review period is on 12-12-11. The Committee approved filing this bill by consent on 10-13-11.

#### CB11-0736 A bill for an ordinance approving a proposed Fourth Amendatory Agreement between the City and County of Denver and Atkins North America, Inc., to extend the term of the contract. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Approves a fourth no-cost amendment to the On-Call General Engineering Services Agreement with Atkins North America, Inc. to extend for one year, leaving one more one-year option, with a maximum work order amount of \$500,000 and a total amount not to exceed \$2,500,000. The last regularly scheduled Council meeting within the 30-day review period is on 12-12-11. The Committee approved filing this bill by consent on 10-13-11.

#### CB11-0776 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Jacobs Investments, LLC dba Colorado Boring Co., for traffic signal system improvements. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Approves a \$588,253.50 contract with Colorado Boring for traffic signal system improvements at 52 intersections. The last regularly scheduled Council meeting within the 30-day review period is on 12-12-11. The Committee approved filing this bill by consent on 10-27-11.

CB11-0824 A bill for an ordinance amending the revocable permit granted by Ordinance No. 393, Series 1989 to TCNC, LLC to add additional items to encroach into the Encroachment Area and to add additional right-of-way

### to the Encroachment Area at 17th Avenue and Humboldt Street. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Amends the revocable permit approved in 1989 to allow TCNC, LLC to encroach into the right-of-way with a glass and metal patio enclosure over a current outdoor patio at 17th Ave. and Humboldt in Council District 8. The Committee approved filing this bill by consent on 11-10-11.

## **CB11-0826 A bill for an ordinance vacating a portion of W. Mulberry Place at the intersection of Wyandot Street, with reservations over a portion of the vacated area. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)** Vacates a portion of W. Mulberry Place currently not being used as public right-of-way at its intersection with Wyandot to allow for site and area improvements in Council District 9. The Committee approved filing this bill by consent on 11-10-11.

#### CB11-0827 A bill for an ordinance approving a proposed Revival and Second Amendatory Agreement between the City and County of Denver and Augusta Consulting to extend the term of the contract for the continued supervision, oversight and management of various projects as part of the Better Denver Bond Program. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Amends a no-cost extension to Dec. 31, 2013, of the contract with Augusta Consulting for continued supervision, oversight and management of various Better Denver Bond projects. The last regularly scheduled Council meeting within the 30day review period is on 12-12-11. The Committee approved filing this bill by consent on 11-10-11.
