A BILL

For an ordinance making a supplemental appropriation from the General Contingency Fund for the operations of the new Mayor’s Office of the National Western Center to support delivery of the November 3, 2015 voter approved ballot measure 2C to design and construct Phases 1 and 2 of the National Western Center.

WHEREAS, the successful passing of ballot measure 2C during the November 3, 2015 election provides for \$1,335,500 to establish the operations of the new Mayor’s Office of the National Western Center; and

WHEREAS, \$493,500 will be budgeted in 2016 for the operations for the Mayor’s Office of the National Western Center and \$842,000 will be budgeted for the 2016 Legal Support and Services for said project;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred to the General Fund:
