Dear City Council Members,

I urge you to listen to your constituents within the Ballpark Neighborhood and Arapahoe Square areas. We stand united in our opposition to the proposed Day Center for the Denver Rescue Mission.

As a long term adjacent business owner (53 years here), a dedicated volunteer to the Colorado Coalition for the Homeless (6 years), a member of the Ballpark Neighborhood Association (6 years), and friend and donor of the Denver Rescue Mission - I urge you to more carefully consider the true irresponsibility of spending the tax payer dollars to build a \$8.6M day center to simply hide the queue. Why is this money being spent to build a facility that will offer daytime refuse to the very few that seek it? There is no demand for a facility like this (simply our City's desire to hide the lines); there is overwhelming demand for housing.

Our company has shared an alley with the Denver Rescue Mission since it located to the neighborhood in the late 1970s. We've long since dealt with the queue (as it has a tendency to align our building nightly) as well as all the other consequences that go along with being a neighbor to an emergency shelter. We manage the element to the best of our ability. We've never put pressure on the City to build a facility to deal with the lines. Who is asking for this project? It is not the adjacent neighbors.

I urge you to rethink this project. There are so many other ways to responsibly spend this money. Give the homeless community what they so tremendously need - affordable housing.

Please distribute to all City Council members.

Hello, please distribute to all council members, thank you:

I have spent the last 35 years (1979) working one block from the Rescue Mission on Lawrence and Broadway.  
Before retiring my father worked the same business here for 35 years going back to 1955.  
The name of the business is Cocks-Clark Engraving Company (dbaCocksClark Graphics Inc.) and has been at this location consecutively since 1929.  
I come from a Catholic, Jesuit, Christian upbringing and I am as sympathetic to the poor as anyone.

Running a business near a shelter would be unimaginable for most people, while all the good that is going on there, it is mirrored with drug peddling and abuse, crime, human defecation on our sidewalks and menacing style of panhandling.  
We have often lost business due to a tangent element that surrounds this neighborhood, I am asking that some public discussion may take place before City Counsel votes to award money and to expand and hide this problem.

The homeless people in the ballpark neighborhood need a LASTING helping hand.  
I don't believe they want to panhandle and deal in drugs and crime. I believe they want a JOB.  
Why can't we create some jobs with this grant money and put them to work like Franklin Roosevelt did in his New Deal Programs.  
Instead of spending money to build walls to hide them from the public.  
This grant money could be spent doing much more positive things like getting people busy feeling good about themselves.

Instead of expanding in this neighborhood, why not discuss sharing the burden of the homeless situation.

Council members,

I'm writing you to express my great frustration with how you are handling the proposal to spend taxpayer dollars to fund the Lawrence Street Community Center. Not only do I disagree with the notion that this will improve the problems Denver's homeless population faces, but I am very disappointed in the expedited manner of which you are pushing this project through. I attended the hearing where all but one of you voted to approve the funding of your constituents' tax dollars, while openly denying us a chance to voice our opinions on the matter. Perhaps you feel this is not deserving of an open discussion? Councilwoman Montero, how is it you feel the business owners and residents of the Ballpark and Lodo Neighborhoods are not deserving of a say in the matter? We elected you to be our voice not our silencer! Shame on you. Ms. Susman, how can you oversee such a significant financial expenditure with even greater social consequences rushed through without any open public dialogue? Apparently you feel this type of project is OK to approve while only consulting the members of the Denver Rescue Mission. And apparently you think it's OK to deny a voice to the representatives of the thousands of tax payers living and working in this district.

Despite Councilwoman Montero's notion that this will provide additional services to the homeless, it DOES NOT. It merely provides a courtyard to hide the expanding homeless problem that you have done nothing effectively to address since Denver's Road Home has begun. These people need psychiatric and addiction services. They need job training. Not a wall to stand behind where everyone (drug dealers included) will be permitted access. This will only make the neighborhood more dangerous than it already is.

I implore you to stop this expedited process of approving the Lawrence Street Community Center and allow an open dialogue consulting all Denver Citizens that this will effect....Not just the Denver Rescue Mission.

Hello City Council-

I am Writing this email as a concerned business owner and native of the Denver metro area. I just want to give you some information I have gathered about the two homeless shelters that Dave the COO from the Denver Rescue mission keeps using as examples for this project.

The Phoenix Rescue Mission is 5.31 miles from Chase Field, that is Arizona's Major League Baseball Stadium. A big reason for this is not enough beds and not everyone wants a bed when the courtyard closes. So when the courtyard closes you have hundreds of homeless, drug/alcohol users flooding the streets of your city. The Denver Rescue Mission will be closing it's courtyard at 10pm right around the time Rockies games get out and all of the people that don't want a bed will be out on the street for the remainder of these nights. With the mission not worrying where they go or what they are doing once they step foot outside of there facility. They provide zero cleanup for the area, security or additional police force for these problems.

The Distance from Dodger Stadium to it's rescue mission is 2.7 miles. Again a big reason for both of these places doing this is the users and alcoholics don't want to be in a bed where they cant consume there poison of choice and these city's decided to protect one of there city's biggest investments which is there Major League Baseball team and stadium.

One of you needs to have the courage to stand up to this and at least slow it down and look at all other possible options and here out your community and taxpayers. There are better options than this that could add more beds and more outdoor space. I think you have a duty to protect the ballpark neighborhood and the investment of Coors field. 8.6 million dollars is a lot of money and with that and the sell of there property they could build a much bigger and better facility just outside the city with more beds and land for a larger outdoor area.

Judy Montero is not the council member to listen to on this issue. We know where she stands and has for a very long time. She has let down all the business's and residence in her district and has not listened to any of us. This is not the best thing for our great ballpark neighborhood. Please reconsider the decision to move forward with this and at least have a public hearing and examination of all other options, because there are better options.

Dear Denver City Council, please share my email with the entire City Council

I had written to some of your members already raising my concerns but the lack of interest of the city to share and explore the best solution for the homeless and the community together and the intent of the city to rush the approval through without letting the wider community voice their opinion on the use of taxpayers money is highly concerning and shortsighted.

Firstly, we all agree there are not enough services for the homeless and every winter this is a concern and we cannot end homelessness until we provide more beds.

Secondly, spending \$8.6M of taxpayers money in creating a "holding pen" for the homeless so that they can be less visible and a "safer parking lot" for Rescue Mission employees and volunteers is simply trying to cover up the lack of progress and highly insensitive towards the homeless and shows the city and Rescue Mission's awareness on the high crime and lack of safety in the area

Thirdly, the same \$8.6M of taxpayers money could be invested right away in building a center for homeless in a cheaper piece of land (perhaps 2-3 miles further from the city center) where the investment will go further and enable more homeless people not only to have a warm bed at night but also more services including training, rehab and support. This is a better use than a holding pen for the homeless and a parking lot for the Rescue Mission.

Fourthly, the Rescue Mission existing center could keep its doors open for longer during the day for far less money than \$8.6M and hence accomplish more with the existing center while investing in better services. This will also enable the Rescue Mission and city to evaluate the true need during the day versus more beds and permanent housing on a regular basis and free funds for true services to end homelessness.

In addition, the city does not have the tools or police resource to provide safety in the area today and increasing the density of crime and homeless in 4 blocks is utterly irresponsible.

Finally, the way that the city council is handling this proposal raises many concerns around potential irregularities. The proposal was not shared with the wider community in detail until March, the process is on a fast track path to get it approved quickly and at the last session when community members wanted to voice their opinions, when the speaker asked if the

community should be allowed to speak, the council member, who was elected to represent the district and all its constituents, chose not to want to provide a voice to the community.

As a Denver resident in the Ballpark area and a taxpayer, I am requesting for a review of the process and the reasons for rushing this decision versus exploring most effective uses to serve the homeless with taxpayers money.

Today is a big day for small businesses in the ballpark neighborhood. You have the power to make a decision that will forever impact the look, feel, and safety of downtown Denver.

Remember that you are elected to be the voice of tax paying residents and businesses in Denver!

Let me give you some background on how I am involved in this issue. I am an owner of 2201 Lawrence street - the largest hangout area for the homeless population. Everyday we have to go and clean our property for 30 minutes in order to avoid city fines for the large amounts of trash that is left behind from the missions clientele. We pick up heroin needles, crack pipes, crack rocks, human feces, and urinated clothing on a daily basis. I would love to think that the courtyard "hangout" area would eliminate these problems but I can tell you that it wont. We live it every day and I can tell you that while there are people that the courtyard will help, there are more that will continue to do what they do best - receive free food, clothes, and services, while being allowed to pan handle at over \$10 an hour to buy drugs and consume them outside of my building. The programs in town have made this a very entitled group of people. Large gatherings exist in front of our building every day and when we arrive to put in a hard day work we are greeted, at our front door, with threats since we call the police so much. Threats include - I am going to fucking kill you white boy - Keep calling the police and see what happens to you - You think you can fuck with us? We run this bloc - To name a few. These are service resistant people that live a very easy life that is fueled by free services drugs and illegal activity. Do you think the courtyard is going to save these people? Do you think they will want to be in the missions courtyard? You are delusional and very disconnected from the issue if you think so. Even if they do use the courtyard, what happens when they all hit the streets with no where to go at 10pm?

It may seem like this is something good to do for the homeless population but this funding will not expand their capacity nor their services and is a gross misuse of taxpayer funds. The fact that \$8.6 million does not expand the capacity of the mission is mind blowing. Since there are not enough beds for the homeless, the courtyard will close at 10pm which will result in hundreds of homeless flooding the streets of ballpark/Iodo area with no where to go other than sidewalks, storefronts, alleys, and parking lots. This crowd brings with it a lot of crime that includes, drug use, drug sales, prostitution, violence and littering. Do you know how bad that will make the neighborhood at 10pm, the most common time for Denver's youth to hit the town? Why do they need the money to build a courtyard when their current facility isn't even open during the day? Why don't we start with the Mission letting people hang out in their current facility all day?

We have met with Councilwoman Judy Montero and Councilman Albus Brooks and it has become very obvious that our voice has not been heard nor does it matter what we have to say. We pay excise tax on top of sales tax, occupational privilege tax, and employee taxes. We spent of \$400,000 on taxes last year! It is a shame that our voice on the matter seems to be drowned out by the fact that the government is looking to push this through as fast as possible.

The Downtown area has proven to be a toxic area for homeless services as it leads to drug dealers poaching the homeless population and being able to quickly escape police activity by walking away and blending in. Hiding the homeless (that are willing to use the courtyard) with a 10 foot wall until 10pm is simply a bandaid that wont fix anything. I challenge you to really get to know this issue by going down to the ballpark neighborhood at 6pm to walk around, better yet, 10pm. Tell me if you feel safe. Ask the people you see if they want to be in a courtyard where services will be pushed on them - most of them will say no way. Ask them if the crime at 10pm will be just as big if not bigger than it already is because there will be a huge influx of homeless drug addicts hitting the streets. It is appalling that the City is willing to spend \$8.6 million to build a courtyard facility that will not provide the services that are most needed by the homeless. I believe that the proposed expansion is simply a Band-Aid fix and is not dealing with the root causes of homelessness. Funds can be much better spent if housing and mental health services would be provided.

I would like to know why City Council and the City is not allowing public dialogue about this issue. The expanded facility will have a huge impact on the neighborhood, a neighborhood that already has 90% of the human services for the entire city. Why is City Council and the Mayor's office pushing this through at breakneck pace? Perhaps because you know that the people in the neighborhood are against it? Please slow the process down so other facilities can be studied that will actually provide the services that the homeless need. Does Council actually believe that adding more human services to a neighborhood already very heavily burdened by human service providers is good for our neighborhood? We already have the highest crime rate in the City and it will get worse if additional services are added.

I believe that City is manipulating the truth to call this a "community center". It is an expansion of the Rescue Mission. If the proposed project goes through, the Rescue Mission will fund part of it, the Rescue Mission will manage it, and the Rescue Mission will feed its overnight clients there. Call it what it is. This will not be a community center that typical city residents will go to.



Please let me know if you have time to meet about this issue. The safety and security of our employees and customers is at risk, and the needs of the homeless are not being met. It is not the right solution to the problem. Please slow the process down to allow public dialogue and I am sure that with more time, we can come up with a solution that is better for the homeless and better for the neighborhood.

As a long term adjacent business owner (53 years here), a dedicated volunteer to the Colorado Coalition for the Homeless (6 years), a member of the Ballpark Neighborhood Association (6 years), and friend and donor of the Denver Rescue Mission - I urge you to more carefully consider the true irresponsibility of spending the tax payer dollars to build a \$8.6M day center to simply hide the queue. I am a pediatrician at Children's Hospital Colorado and deal daily with the effects of poverty and homelessness on children. The solution to the problem is not easy and there is no quick fix. I support the Colorado Coalition for the Homeless' longterm plan to cut down homelessness at its roots by providing sustainable low-income housing, employment opportunities, and mental health resources. Hiding the homeless population in a new courtyard facility of the Denver Rescue Mission is the wrong option.

My wife is a business owner in the Ballpark neighborhood. For years, she has rallied behind the Colorado Coalition for the Homeless and has been an active advocate for the homeless (not a popular stance in the business community). She has hired workers from St. Francis and helped them get back on their feet. Despite the panhandling, littering, and harassment of potential clients outside of her business doors, she remains dedicated to seeking long-term solutions to the problems facing the destitute of her neighborhood. This proposed project will be to the detriment of local businesses in the area, and a scab, not a solution to the long-term problem of homelessness.

Thank you for contacting my office regarding the proposed Lawrence Street Center in partnership with the Denver Rescue Mission. I have been an advocate for improved homeless services throughout my tenure on Council, as well as transitional and permanent affordable housing. I believe the location of the proposed Lawrence Street Center provides a critical service for the health, safety, and life of the individuals seeking other resources in the Ballpark neighborhood. While I understand your concerns about the magnitude and concentration of services in this area, institutions like the Denver Rescue Mission existed

long before the stadium itself or the associated commercial and residential development that took off along with the stadium in this area, and it is neither just public policy nor financially practical to expect these long-standing service providers who also own their property to simply relocate.

I do support the Mayor's recent commitment to increasing resources for neighborhood improvements. And I also agree with the concerns that many opponents have raised about simply moving the problem of homelessness out of sight without taking action to solve it. While the courtyard is a more humane and safer environment for men and women to wait for services than the busy streets and sidewalks currently used by the homeless community, and therefore a step in the right direction I strongly support for both the community and the homeless community, the one and only step the city can take to truly end homelessness for an individual or a community is to provide safe housing. That needs to be the next priority, it needs to be funded and advanced more quickly and far more robustly than it has been to date, including with Denver's own dollars. And it will require leadership from all segments of our community. I have and will continue to champion the creation of homes, both transitional with intense services and permanent with on-going services, and I hope that your neighborhood will continue to champion these outcomes as well, even if our reasons for doing so may differ.

Dear Honorable Members of the City Council,

I'm writing to express my concern regarding the proposed Lawrence Street Community Center.

I'm a resident/homeowner of the Ballpark neighborhood, so I see every day the effect of the hugely disproportionate concentration of homeless shelters in my neighborhood (and the effect of the drug dealers and crooks that prey on the homeless). I've cleaned feces and vomit from my doorstep. I've called ambulances for passed out and desperate people sleeping on my sidewalk. I've seen the drug use and can point out the dealers. I've witnessed the crimes against property and people. I deal every day with the fact that, for some reason, the city has decided that the vast majority of homeless resources should be concentrated in one neighborhood.

On Monday, Mayor Hancock wrote a letter to the City Council indicating that he would attempt to allocate an undisclosed amount of funding to increase police patrols and cleanups in the neighborhood. I fully support that effort, but the timing is deeply disturbing to me. It is unacceptable to me that in order to induce residents like me to accept the proposed Lawrence Street Community Center, the City must promise us the increase in police patrols and clean up efforts we've desperately needed for years. Promising to provide the basic level of city services to residents is not how you sweeten the bitter pill of increasing the burden already placed on the Ballpark neighborhood. It is an acknowledgement that something is deeply wrong and has been for years.

It's also deeply disturbing to me that the decision to spend \$8.6 million dollars to expand a homeless shelter in a neighborhood with a growing residential population is about to occur with almost no efforts to engage those residents in a dialogue. When a ban on alcohol in Washington Park was proposed, there was a town hall meeting attended by members of the City Council. Where is our town hall meeting? How can you possibly feel comfortable spending so much money on a project without soliciting substantial input from people it

would actually effect? (And, for the record, I don't believe that behind-closed-door conversations with neighborhood association representatives counts.)

Building a wall to hide the homeless and promising one or two more officers on patrol does nothing for a neighborhood that's trying to raise itself out of a long history of urban blight.

The City needs to acknowledge that it has utterly failed to truly address the issues in this neighborhood for years, all while feeding off the growing property tax base paid by the residents here and the sales taxes generated by our business owners.

This proposed "community center" is a glorified waiting room--a place to hide the homeless behind a wall--and it's another in a long line of poorly conceived efforts to clean up the neighborhood. Sure, you fenced off Triangle/Maestas Park, but what has that done? Forced the most drug-addicted and mentally unstable homeless and the dealers who prey on them into the adjacent streets. Sure, you implemented a camping ban, but what has that done?

Caused the homeless to squeeze into our alleyways and doorways to sleep, urinate, and defecate out of sight. Putting up a wall is not going to get these people the help they need. Please, please reconsider.

If the city can demonstrate a commitment to addressing homelessness and its affect on the Ballpark neighborhood (and, in doing so, a commitment to actually understanding them, rather than making decisions behind closed doors), then you'll have my full support (including for the use of public funds to improve shelter resources). But at the moment I'm afraid you haven't earned my trust or the trust of my neighbors. I truly hope you decide to increase the police presence here and commit to cleaning up the filth that has accumulated over so many years. I hope you don't feel the need to condition the provision of those services on the neighborhood's support for the expansion of the Lawrence Street Shelter. If the city wants to play ball, I'm game, and I'll be on your team. But until I see a commitment from the city to support the neighborhood and not just the shelters, I can't say I'm convinced that your proposal of greater city involvement is anything but a false promise to keep people like me quiet.

There are clearly more outlying areas near some of the newer RTD stations for help with transporting the folks hopefully to new jobs that our area and neighboring areas will be more able to provide. A very nice facility could be set elsewhere for much less land acquisition cost saving the City a great deal of money and thereby letting the natural course of business purchase the Capra properties to further bolster the neighborhood making it much more viable and generating much more tax for the city.

This is not a constructive solution. It does nothing to improve the homeless situation in Denver. What does a place to sit during the day do for anyone? It is likely to be as effective as closing Triangle Park was, which is to say, not effective at all and simply a sweep of the issue to other blocks. All the closing of Triangle Park achieved was the creation of "Hamsterdam" (from the tv show The Wire) on 22nd St. If that reference is lost on anyone, 22nd St. is an uncontained, terrible mess with garbage everywhere and a "free zone" of drug dealing. Ostensibly, the closing of Triangle Park was to help the homeless get away from predatory drug dealers. It did nothing for anyone.

Invest in beds, invest in housing, invest in education, etc. Don't invest in another futile attempt to mask a vexing problem. Also, I know other neighborhoods aren't excited about the prospect of taking on the homeless population, but this idea stands right in the line of Denver's potential growth and is completely disagreeable to everyone in the area and certainly to potential investment that might do much more for the prosperity and well being of this city overall. And the neighborhoods' opposition is not necessarily centered on the creation of more homeless services infrastructure hereabouts, but poorly planned out investment.

It is really incumbent upon you all to provide research as to why this is a good, well researched investment. Have you studied other cities that have implemented something like this with a constructive impact on homelessness? Denver's homeless problem is worse than many comparable cities, in part, because of poor planning and investment in infrastructure. Please do not rush to do this and please provide grounded rationale.

As a long term adjacent business owner (53 years here), a volunteer to the Colorado Coalition for the Homeless, and friend and donor of the Denver Rescue Mission - I urge you to more carefully consider the true irresponsibility of spending the tax payer dollars to build a \$8.6M day center to simply hide the queue. Why is this money being spent to build a facility that will offer daytime refuse to the very few that seek it? There is no demand for a facility like this (simply our City's desire to hide the lines); there is overwhelming demand for housing.

Our company has shared an alley with the Denver Rescue Mission since it located to the neighborhood in the late 1970s. We've long since dealt with the queue (as it has a tendency to align our building nightly) as well as all the other consequences that go along with being a neighbor to an emergency shelter. We manage the element to the best of our ability. We've never put pressure on the City to build a facility to deal with the lines. Who is asking for this project? It is not the adjacent neighbors.

I urge you to rethink this project. There are so many other ways to responsibly spend this money. Give the homeless community what they so tremendously need - affordable housing.

Dear Mayor Hancock, Councilwoman Montero and Councilman Brooks:

We are writing today to clarify the position of the Ballpark Neighborhood Association regarding facilities serving homeless people, including the Denver Rescue Mission (DRM). You may have seen a letter from John Parvensky of the Colorado Coalition for the Homeless stating that “we cannot state more strongly that we do not support the efforts of the Ballpark neighborhood to relocate the DRM.”

The implication of Mr. Parvensky’s statement is simply incorrect. The Ballpark Neighborhood Association has not proposed relocating the existing DRM facility.

To the contrary, we have embraced the DRM. A DRM staff member sits on our board. We have participated as a board and as an organization countless times over the years in volunteer programs at the DRM – organizing turkey drives over Thanksgiving, volunteering to serve holiday meals, making donations, etc.

We are a diverse community and people in the neighborhood have many viewpoints on this issue. However, the Ballpark Neighborhood Association has never advocated for the relocation of the Denver Rescue Mission and has a long history of working with the Rescue Mission as our neighbor.

This correction is important because this is not a debate over whether or not Denver should help homeless in any one part of the city. Rather, it’s about what’s the best use of the communities’ limited funds. The association is concerned that the \$8.6 million proposal is a Band-Aid that won’t offer the long-term housing, treatment and job training that is needed to help homeless people get off the streets for good.

We support the Denver’s Road Home 10-year plan to end homelessness – not just to hide homeless people in a courtyard behind 10-foot walls – and believe that the goal of ending homelessness should remain the city’s focus.

Interestingly, Mr. Parvensky notes in his letter: “The Coalition was not asked to provide advice or input into the development of this project. Nor was the Homeless Commission, of which I am a member, asked to review or give its input. Thus, what I know about the project is only what I have gleaned from media reports or third hand accounts.”

Despite claims that there was extensive public outreach and engagement, the Ballpark Neighborhood Association also feels that we have largely been left out of planning for this project, first learning the

details just last month. This lack of stakeholder engagement suggests a deeper problem and may be at the root of the public concern over this project, as evidenced by a Denver Post online survey. With 6,787 votes, 57% of respondents to the Post survey said that they opposed the proposed Lawrence Street project. That finding should give the city pause.

I know this is the 11th hour and first want to thank you for your service. I have spoken with some of the council members who have been very insightful and helpful but want to send my thoughts to the larger group before it is too late as I mistakenly thought the vote was next week.

My name is Alex Jarboe and I am a co-owner of a new business in the Ballpark Neighborhood at 20th & Lawrence. My fiancé and I are opening a yoga studio together and very excited to be a greater part of the Denver community and provide yoga to the area. This has been a dream of ours for a very long time.

I am writing because I am concerned and opposed to the current proposal and strategy regarding the Denver Rescue Mission because of the following;

- We are concerned for the safety of our clients and employees when this facility closes at night.
  - We believe this new adjustment to the mission will attract a greater number of homeless from the Denver area to LoDo. Our business will be open till 10:30pm throughout the week and want to ensure the safety of our customers and employees when the proposed facility closes for the evening. Am I wrong that the facility will close for the evening and the people at the facility will need to leave for the night to find other space? What and where will all those folks go at this time if this is the case? We have already had minor thefts from our construction site and want to ensure the utmost safety for our employees and clientele during the night time hours when the proposed facility will be closed for the evening. More street lights, police presence and funds spent to remove graffiti/trash is positive, however, this seems more of a symptom assistance than root solutions. But have faith you are there to help us.
  - We want to create safety protocols to assist our employees within our organization to assist with potential problems and hope that we can work closely with the city to help, first the root causes, but also the symptoms that arise on the

surface of the streets.

Do you have any thoughts or contacts in whom we can include in our safety and security protocols for our employees and teachers at our studio? Any thoughts on how we can help create a strong organizational protocol?

- We believe the local economic vitality will be affected adversely and diminish this newly sought after area regarding commercial businesses and residential facilities.
- We believe importantly that the homeless population is not being served in the most effective and efficient way with city dollars.

We strongly support the goal of Denver's Road Home to end homelessness. However, we believe that quick fixes like this one will not provide the best long-term solutions for our city or our citizens. By moving this facility to less expensive real estate, city funds could be better allocated to root problem solutions.

We support directing our community's limited resources to address the root causes of homelessness through comprehensive strategies like:

1. Long Term Housing
2. Treatment & Revocery programs
3. Job Training

Examples of local communities that have been able to provide better services to homeless by moving and expanding shelters outside of downtown areas are places like Ft Collins and Boulder.

Please join the Colorado Coalition for the Homeless, The Ballpark Neighborhood Association, myself, and other residents and businesses to re-strategize and create a more effective plan to help support the homeless population and protect the economic vitality of the expanding area.

We understand the mayor's office is doing its very best to address this issue and has made promises to make strides forward, but do not want this expensive option to be the only option in a rushed attempt to say a promise has been fulfilled.

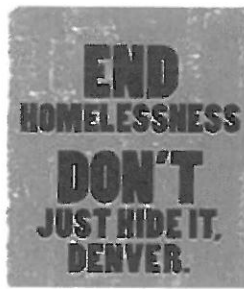
