A BILL

For an ordinance approving Service Plans for the creation of 9th Avenue Metropolitan District No. 1, 9th Avenue Metropolitan District No. 2 and 9th Avenue Metropolitan District No. 3 relating to the redevelopment project at approximately 9th Avenue and Colorado Boulevard.

WHEREAS, upon publication of notice, City Council held a public hearing regarding the formation of 9th Avenue Metropolitan District No. 1, 9th Avenue Metropolitan District No. 2 and 9th Avenue Metropolitan District No. 3 (collectively, the “Districts”), on December 8, 2014; and

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That upon consideration of the Service Plan For 9th Avenue Metropolitan District No. 1, the Service Plan For 9th Avenue Metropolitan District No. 2 and the Service Plan For 9th Avenue Metropolitan District No. 3 (collectively, the “Service Plans”), the conclusions contained therein, and other facts and information, including holding a duly noticed public hearing, the Service Plans for the Districts, available in the office and on the web page of City Council, and filed in the Office of the City Clerk of the City and County of Denver on the 25th day of November, 2014, Filing Nos. 2014-0952, 2014-0953 and 2014-0954 respectively, are hereby approved.
