6 **For an ordinance relinquishing a portion of the easement established in the Deed**
7 **of Easement, recorded with the Denver Clerk & Recorder at Book 9410, Page 464,**
8 **bounded by Warren Avenue, Evans Avenue, South Colorado Boulevard and**
9 **South Ash Street.**

10 **WHEREAS**, the Executive Director of Public Works of the City and County of Denver has
11 found and determined that the public use, convenience and necessity no longer requires the
12 easement in the area hereinafter described, and subject to approval by ordinance, has relinquished
13 the same;

14 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

15 **Section 1.** That the action of the Executive Director of Public Works in relinquishing the
16 easement in the following area:

17 **PARCEL DESCRIPTION ROW NO. 2016-RELINQ-0000012-001:**

18 A portion of that property described in Deed of Easement, Book 9410, Page 464, recorded April 9, 1965 at
19 the City and County of Denver Clerk and Recorder’s Office, located in the Northwest Quarter of Section 30,
20 Township 4 South, Range 67 West of the Sixth Principal Meridian, City and County of Denver, State of
21 Colorado, more particularly described as follows:

23 The West 10 feet of Lots 30 to 34, inclusive, Block 1, Warren’s University Heights,
24 City and County of Denver, State of Colorado, except the South 3.00 feet thereof.
