

SECOND AMENDATORY AGREEMENT

THIS SECOND AMENDATORY AGREEMENT by and between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the “City”), and **SHOTSPOTTER, INC.**, a Delaware corporation, registered to do business in Colorado, whose address is 7979 Gateway Blvd., Suite 210, Newark, CA 94560 (the “Contractor” also “ShotSpotter,” “we,” “us,” or “our”).

WITNESSETH:

WHEREAS, the Parties entered into an Agreement dated December 10, 2015 and a First Amendatory Agreement dated April 12, 2017 (the “Agreement”), relating to a subscription to the ShotSpotter Flex System which detects loud impulsive incidents, classifies them as gunfire, fireworks, or other, and sends them to the SST Incident Review Center; and

WHEREAS, the Parties wish to amend the Agreement to expand the scope of coverage and increase the compensation to the Contractor.

NOW, THEREFORE, in consideration of the premises and the mutual covenants and obligations herein set forth, the Parties agree as follows:

1. Article 1 of the Agreement entitled “SERVICES TO BE PERFORMED” is amended to read as follows:

1. “**SERVICES TO BE PERFORMED**: Contractor, under the general direction of, and in coordination with, the City’s Manager of Safety or other designated supervisory personnel (the “Manager”) agrees to perform and deliver the services described on **Attachments 1, 2 and 3** (the “Statement of Work” or “SOW”) and to expand the current coverage to include **Attachment 4**.”

2. Article (D)(i) entitled “Maximum Contract Amount” is amended to read as follows:

“4. **COMPENSATION AND PAYMENT**:

“D. **Maximum Contract Liability**:

(i) Any other provision of this Agreement notwithstanding, in no event shall the City be liable for payment for services rendered and expenses incurred by Contractor under the terms of this Agreement for any amount in excess of the sum of **ONE MILLION NINE HUNDRED SIXTY-FOUR THOUSAND NINE HUNDRED AND NINE DOLLARS AND 00/100 CENT (\$1,964,909.00)**. Contractor acknowledges that any work performed by the Contractor beyond that specifically authorized by the City is performed at

Contractor's risk and without authorization under this Agreement.”

3. Except as herein amended, the Agreement is affirmed and ratified in each and every particular.

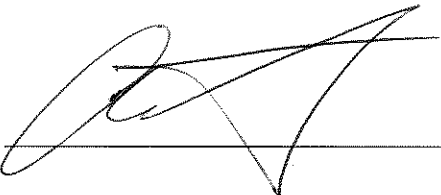

Coverage Area Details:

- Coverage area footprint is determined by customer's needs and requirements.
- SST hosts, secures, monitors and maintains all infrastructure.

Coverage Area

Systems are deployed to provide a dome of coverage for a specified area. The area is bounded by a specific coverage area perimeter. The area to be covered is shown in the map image below, with the coverage area denoted by a shaded polygon. The map and the coverage boundaries were provided by the City. The area outlined in the image is a rough estimate of the recommended coverage area and may not be exact. The precise size of the area (e.g., in square miles or square kilometers) can only be verified with actual acoustic propagation information. This verification can only be accomplished during the installation process, therefore the shape may vary.

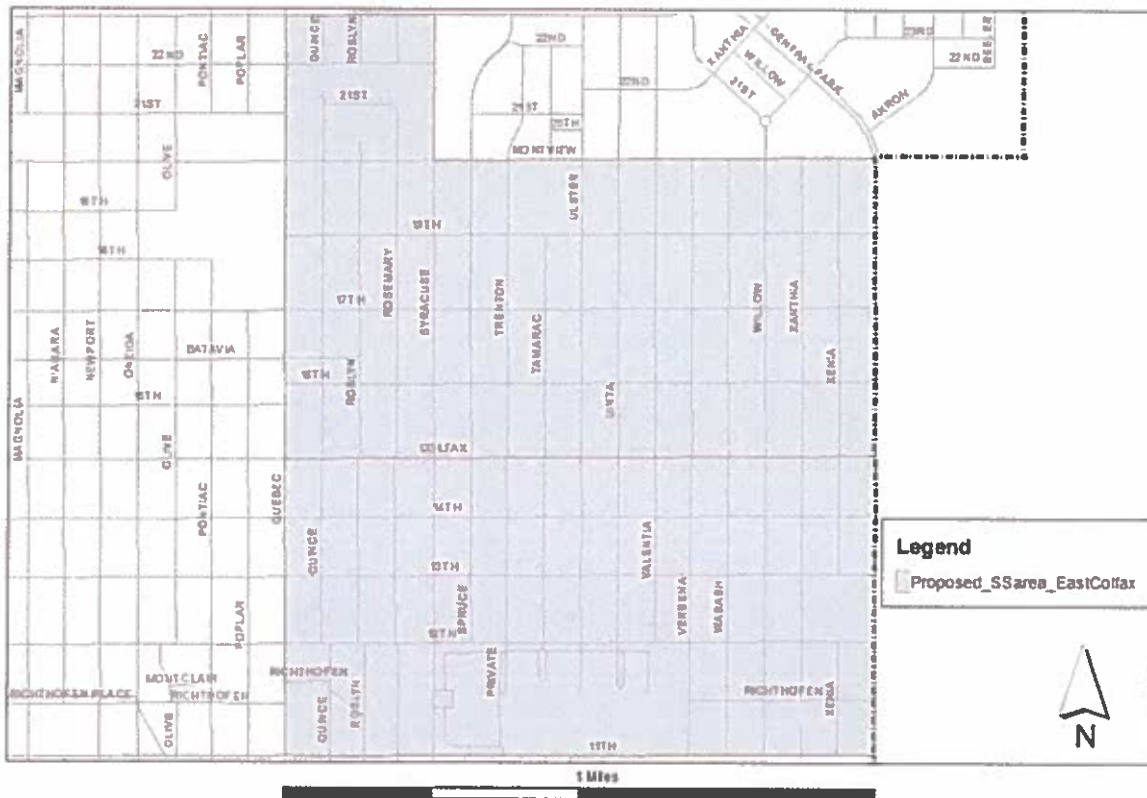


Figure 1: Proposed ShotSpotter Coverage Expansion = 1.10 mi² (East Colfax area within District 2)
