A BILL

For an ordinance designating and incorporating as “park” under section 2.4.5 of the City Charter a portion of certain property known as Lindsley Park.

WHEREAS, the following real property which is under the jurisdiction of the Denver Department of Parks and Recreation, has been or will be used for park purposes within the City and County of Denver (“Park Property”):

Portions of Lots 35 and 36 North of the right-of-way of Hale Parkway,
Lots 37 through 48 inclusive,
Block 11,
Bellevue Park Subdivision,
City and County of Denver,
State of Colorado.

together with Cherry Street vacated in Ordinance No.1127 Series of 1993 between Hale Parkway and E. 12th Avenue.

WHEREAS, the Parks and Recreation Advisory Board and the Executive Director of Parks and Recreation have recommended that said Park Property be formally designated as a “park” under section 2.4.5 of the City Charter.

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That the Park Property, legally described above, is hereby designated as a “park” under section 2.4.5 of the City Charter, and shall henceforth be regarded as being a designated park in the City and County of Denver.
