8 **For an ordinance making rescissions, cash transfers and supplemental**
9 **appropriations from the General Contingency Fund to Departments;**

11 **WHEREAS**, the Hearing Office needs a budget adjustment for an unbudgeted
12 retirement payout; and

13 **WHEREAS**, the Department of Finance-Real Estate Capital Projects needs a
14 budget adjustment for renovations at the 48th Avenue Shelter, and Denver Human
15 Services will transfer \$1,400,000 for this project; and

16 **WHEREAS**, the Office of Economic Development needs a budget adjustment to
17 cover Aerotropolis marketing as part of a cooperative agreement with Denver
18 International Airport and Adams County; and

19 **WHEREAS**, the Office of the Municipal Public Defender needs a budget
20 adjustment to address increasing criminal investigations, legal counsel needs and
21 interpreter service caseloads; and

22 **WHEREAS**, the District Attorney needs a budget adjustment to offset unbudgeted
23 retirement payouts;
