10 11 12 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

13 14 15 16 17 18 19 20 21 **Section 1.** That subsections (a) and (b) of Denver Revised Municipal Code section 10-16 are amended by deleting the language stricken below and adding the language underlined below to read as follows:

Sec. 10-16. – Denver building code and Denver fire code adopted.

14 15 16 17 18 19 20 21 (a) *Denver building code.* The following codes as published by the International Code Council, all errata to the below codes published by the International Code Council, and the amendments to the below codes filed on November 7, 2025 ~~May 29, 2025~~ in City Clerk File Number 20250180 ~~20250086~~ are hereby adopted as the 2025 Denver Building Code (“2025 DBC”): the International Building Code (“IBC”), International Fuel Gas Code (“IFGC”), International Mechanical Code (“IMC”), International Plumbing Code (“IPC”), International Existing Building Code (“IEBC”), and International Residential Code (“IRC”), all series 2024; and the International Energy Conservation Code (“IECC”) series of 2021.




