5. General description or background of proposed request. Attach executive summary if more space needed:

Establishing the Evans School Urban Redevelopment Area ("Area") will assist in the process of redevelopment of an approximately 0.8-acre area underutilized and blighted site, generally bounded by privately owned vacant property to the north, Acoma Street to the east, 11th Avenue to the south and privately owned residential property to the west. The Area is located within the Civic Center statistical neighborhood, in a mixed-use area known as the Golden Triangle.

The general objectives of the Evans School Urban Redevelopment Plan are to reduce or eliminate blighted conditions as well as to stimulate the growth and redevelopment of the Area. The urban redevelopment project will revitalize the Urban Redevelopment Area through the adaptive reuse of an existing historical landmark, which has suffered from decades of deferred maintenance, to provide community serving retail, enhanced meeting spaces, and office and studio space for the artist community.

The Denver Urban Renewal Authority ("DURA"), in coordination with the City's Department of Finance and Department of Community Planning and Development, is seeking to establish an Urban Redevelopment Area to support the proposed redevelopment of the Area through the approval of an Urban Redevelopment Plan and the authorization of tax increment financing.
