BY AUTHORITY 1 COUNCIL BILL NO. 10-1009 ORDINANCE NO. 2 SERIES OF 2010 3 COMMITTEE OF REFERENCE: Land Use, Transportation & Infrastructure 4 5 A BILL For an ordinance changing the zoning classification for 210 St. Paul St., from 6 PUD #269 to a General Planned Unit Development District (PUD). 7 8 WHEREAS, the City Council has determined, based on evidence and testimony presented at 9 the public hearing, that the map amendment to a PUD as set forth below conforms with applicable 10 City laws; is in accordance with the Comprehensive Plan; is necessary to promote the public health, 11 safety and general welfare of the City; is justified by one of the circumstances set forth in Section 12 12.4.10.14A of the Denver Zoning Code, and is consistent with the neighborhood context and the 13 stated purpose and intent of the PUD zone district stated in Division 9.6 of the Denver Zoning Code: 14 the PUD District and the PUD District Plan conform with Division 9.6; the development proposed is 15 not feasible under any other zone district and would require an unreasonable number of variances or 16 17 conditions and waivers; and the PUD District and the PUD District Plan establish permitted uses that are compatible with existing land uses adjacent to the subject property and establish building forms 18 that are compatible with adjacent existing building forms or which are made compatible through 19 appropriate transactions at the boundaries of the PUD District Plan: 20 NOW THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF 21 **DENVER:** 22 Section 1. That the zoning classification for the land areas in the City and County of 23 Denver described as follows or included within the following boundaries shall be and hereby is 24 changed from PUD #269 to General PUD: 25

in addition thereto those portions of all abutting public rights-of-way, but only to the centerline thereof, which are immediately adjacent to the aforesaid specifically described area.

Section 2. The complete application with such supporting material as designated by the Land Use, Transportation, and Infrastructure Committee of the City Council all as filed in the Office
