

AMENDATORY AGREEMENT

This **AMENDATORY AGREEMENT** is made between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the “City”) and **THE REGENTS OF THE UNIVERSITY OF COLORADO, a body corporate, for and on behalf of the University of Colorado at Denver**, a Colorado public institution of higher education whose address is 13001 E. 17th Place, Box 6508, Aurora, Colorado 80045 (the “University”), jointly (“the Parties”).

RECITALS:

A. The Parties entered into an On-Call Technical and Engineering Services Agreement dated September 19, 2018 (the “Agreement”) to provide technical and professional services as set forth in the Agreement.

B. The Parties wish to amend the Agreement to extend the term.

NOW THEREFORE, in consideration of the premises and the Parties’ mutual covenants and obligations, the Parties agree as follows:

1. All references to “...Exhibit A...” in the Agreement shall be amended to read: “...Exhibit A and A-1...” as applicable. The fee schedule marked as **Exhibit A-1** attached to this Amendatory Agreement is hereby incorporated by reference.

2. Section 4 of the Agreement entitled **TERM AND TERMINATION** Sub-paragraph 4.01 entitled “**Term**” is amended to read as follows:

“**4. TERM AND TERMINATION:**

4.01 Term: The initial term of this Agreement shall commence July 1, 2018 and shall end July 1, 2022; provided, however, that any work in progress that was initiated during the term of this Agreement shall continue and be paid for hereunder until the completion thereof. All terms and conditions of the Agreement shall remain in full force and effect until such completion. This initial term may be extended, at the sole option of the City, for up to one additional year by written amendment. In no event, however, shall the University’s performance under this Agreement, including the possible one year extension, exceed a five (5) year period ending on month and day of the execution of this Agreement. In addition, nothing contained herein shall obligate the City to extend the Agreement beyond the initial term.”

3. As herein amended, the Agreement is affirmed and ratified in each and every particular.

4. This Amendatory Agreement will not be effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.
