**A BILL**

**For an ordinance establishing new Funds in the Sidewalks Enterprise Fund Series (76000) for the “Sidewalks Operating Fund” program, the “Sidewalks Fleet Fund” program, and the “Sidewalks Capital Equipment and Improvements Fund” program.**

**WHEREAS**, the citizen initiative “Denver Deserves” program, passed in November 2022, seeks to improve accessibility for residents and visitors by constructing, reconstructing, and repairing sidewalks to establish a safe, connected sidewalk network that enhances mobility for all, supports transit options, promotes community connectivity, establishes sustainable practices, and stimulates economic vitality; and

**WHEREAS**, Ordinance 1076, series of 2024 approved a municipal code change to DRMC Chapter 49 Division 5 related to the Sidewalk Program and Sidewalk Fund and created the Sidewalk Enterprise Fund series (76000) to make the program financially and operationally feasible; and

**WHEREAS**, Operating expenditures and capital expenditures must be segregated and accounted for in their respective fund types; and

**WHEREAS**, the City’s practice is to account for planned fleet purchases in separate funds, primarily due to the long lead time of said vehicle purchases; and

**WHEREAS**, the Department of Transportation and Mobility (DOTI) desires to create three new funds under the Sidewalks Enterprise Fund Series including an Operating Fund (76100), a Fleet Fund (76200), and Capital Equipment and Improvements Fund (76300), to administer the “Denver Deserves Sidewalks” program;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** New Funds are hereby established in the Sidewalks Enterprise Fund Series, Accounting No. 76000, “Sidewalks Operating Fund”, Accounting No. 76100, for the purpose of accounting for operating funds; “Sidewalks Fleet Fund”, Accounting No. 76200, for the purpose of

1 accounting for fleet funds; and “Sidewalks Capital Equipment and Improvements Fund”, Accounting  
2 No. 76300, for the purpose of accounting for capital funds.

3 **Section 2.** Monies received from charges imposed to support the costs of Denver's sidewalk  
4 system proceeds; fees charged for services; grants from federal and state government;  
5 reimbursements and repayments from other sources; transfers from other funds; gifts or donations;  
6 investment earnings; and proceeds from the sale of bonds, including revenue bonds, or other  
7 sources of revenue, shall be deposited into the Treasury of the City and credited to Special Fund  
8 No. 76000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the  
9 City and County of Denver.

10 **Section 3.** Expenditures are hereby authorized for the “Sidewalks Operating Fund”, Accounting  
11 No. 76100, to be expended by the Executive Director of the Department of Transportation and  
12 Infrastructure. Authorized expenditures for Fund 76100 are for operating expenses related to Denver  
13 Deserves Sidewalks Program. This is a revenue-based and non-lapsing fund.

14 **Section 4.** Expenditures are hereby authorized for the “Sidewalks Fleet Fund”, Accounting No.  
15 76200, to be expended by the Executive Director of the Department of Transportation and  
16 Infrastructure. Authorized expenditures for Fund 76200 are for fleet expenses related to Denver  
17 Deserves Sidewalks Program. This is a revenue-based and non-lapsing fund.

18 **Section 5.** Expenditures are hereby authorized for the “Sidewalks Capital Equipment and  
19 Improvements Fund”, Accounting No. 76300, to be expended by the Executive Director of the  
20 Department of Transportation and Infrastructure. Authorized expenditures for Fund 76300 are for  
21 capital equipment and capital improvement project expenses related to Denver Deserves Sidewalks  
22 Program. This is a revenue-based and non-lapsing fund.

23 **Section 6.** The Chief Financial Officer of the City and County of Denver is hereby authorized  
24 and directed to make such book and record entries and to do such other things as may be  
25 necessary to accomplish the purposes of this Ordinance.
